# CHAPTER 1

## New features and enhancements

The Fall 2020 October release of Informatica Intelligent Cloud Services™ Operational Insights includes the following new features and enhancements.

### Managing alerts

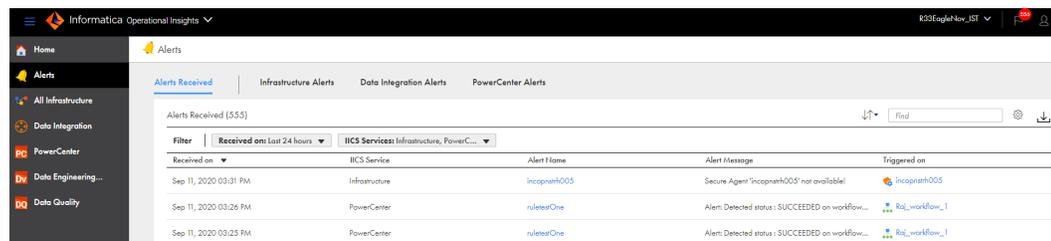
Manage Operational Insights alerts on the **Alerts** page in the navigation bar on the left side of the page.

You do not need to navigate to the specific product workspace in Operational Insights to create or manage an alert. You can use the **Alerts** page to create and manage alerts for different products in one place.

In this release, the Infrastructure and PowerCenter alerts that you previously managed or configured in the product-specific pages are now moved to the common **Alerts** page.

Additionally, the **Alerts** page also includes the **Data Integration Alerts** tab for managing alerts configured for Informatica Intelligent Cloud Services Data Integration.

The following image shows the **Alerts** page:



**Note:** Your organization must have a license to configure the Infrastructure, Data Integration, and PowerCenter alerts. If you do not have the license to configure alerts for a specific service or product, the related alert tab does not appear on the **Alerts** page.

The **Alerts** page includes the following tabs:

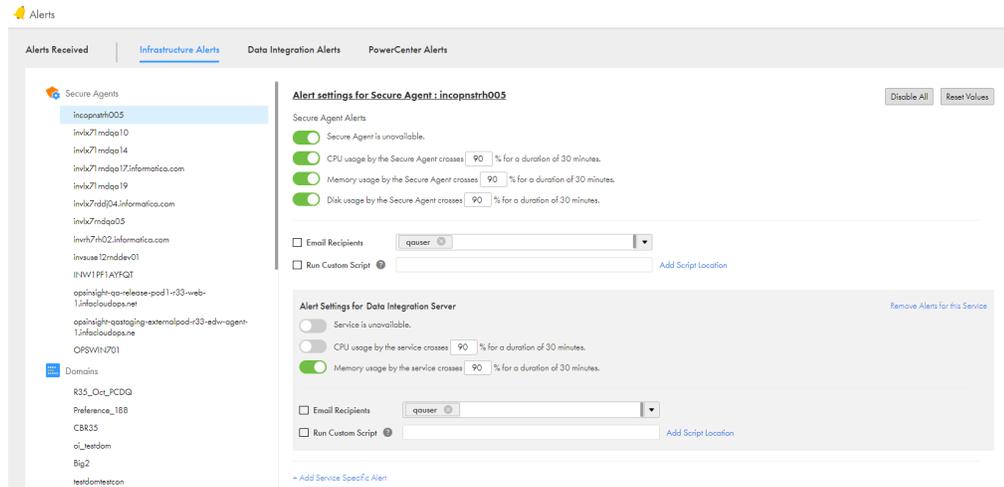
#### Alerts Received

You can view all alert notifications received for issues that occur with all the products or services. You can select the time period to display the notifications received. You can view data for the last 24 hours, the past week, or you can select a custom date range. You can also filter notifications based on product from the **Product/Services** list.

#### Infrastructure Alerts

You can enable or disable individual alerts or all alerts for each domain or Secure Agent that Operational Insights monitors on the **Infrastructure Alerts** tab. You can also reset the alerts on this tab.

The following image shows the **Infrastructure Alerts** tab, with the Secure Agent alerts on the top and the domain alerts on the lower portion of the page:

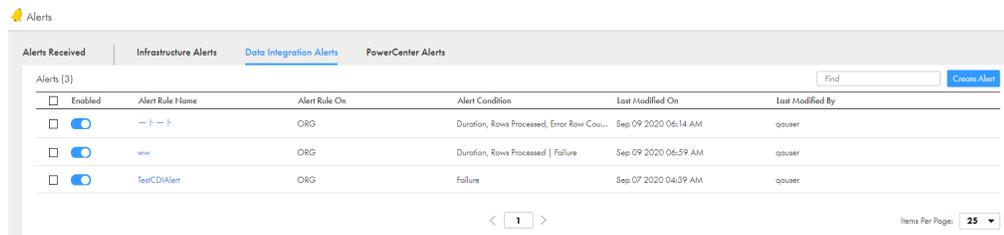


You can specify the Informatica Intelligent Cloud Services users or user groups that receive alert notifications or you can create alert scripts on this page.

### Data Integration Alerts

If your organization uses Data Integration, you can create and manage alerts for Data Integration jobs in the **Data Integration Alerts** tab. The **Data Integration Alerts** tab summarizes the alerts that are enabled, the configured jobs, and the alert condition.

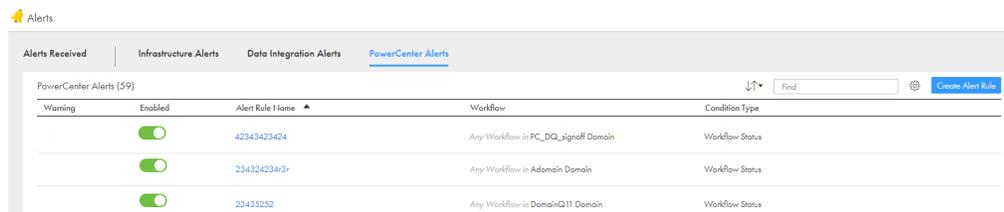
The following image shows the Data Integration Alerts tab:



### PowerCenter Alerts

The **PowerCenter Alerts** tab summarizes what alerts are enabled, the alert rule name for the PowerCenter workflows or tasks, and the alert type generated. You can select **Create Alert Rule** to create an alert rule to send email notifications to a user when an issue occurs in a PowerCenter workflow.

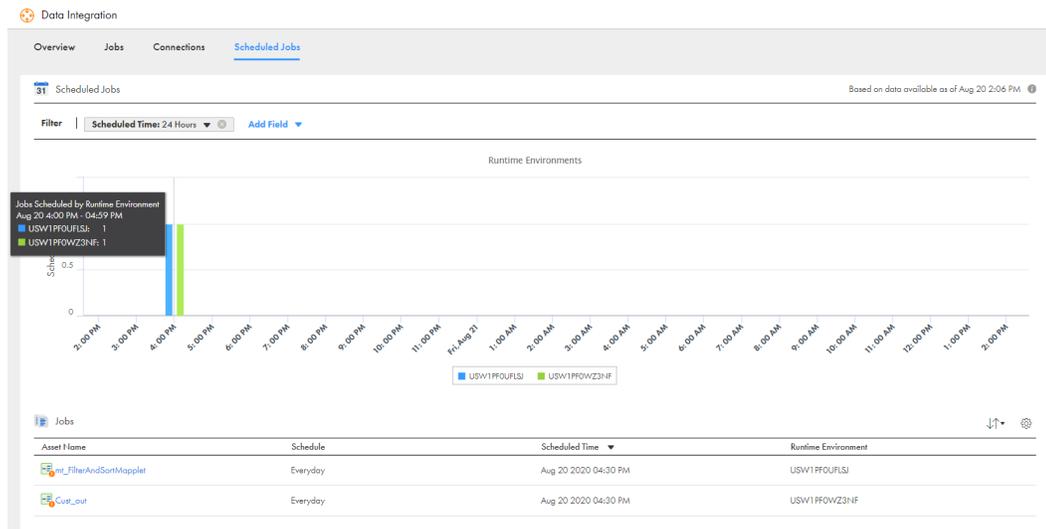
# Data Integration job monitoring

Data Integration job monitoring includes the following updates:

## Scheduled Jobs

You can view jobs that are scheduled to run in the next 24 hours on the **Scheduled Jobs** tab on the **Data Integration** page. The **Scheduled Jobs** page shows a graph of the number of scheduled jobs per hour for each runtime environment in the selected time frame. It also shows the job details for each job in the selected time frame. You can filter the page to view jobs that are scheduled to run in a particular time frame, runtime environment, or schedule.

## Error remediation recommendations

When you view details for a failed job, you can view recommendations to resolve the failure error in the **Insights** area of the **Job Details** page. The **Insights** area displays links to relevant documentation to help you troubleshoot the error.

## Serverless jobs

Jobs data in Operational Insights includes jobs that you run in a serverless runtime environment.
