Data Vault

This section describes new features and enhancements for the Data Vault in version 6.4.4.

Password Enhancements

You can configure Data Vault password policies for users who access Data Vault. Set password policies in the ssa.ini file.

The following password policies are available:

- · Password length.
- Password complexity.
- Password duration.
- Blacklisted passwords.

Security

System-Defined Roles

The following system-defined roles have been added:

Import Metadata Role

To import metadata in the Enterprise Data Manager, either from a database or an exported product family version or exported entity, a user must have the import metadata role. This role is assigned to the Administrator user by default, both in upgrades to version 6.4.4 and new installations. You must assign this role to the user who is importing metadata, either through the Enterprise Data Manager or with the Import Metadata standalone job. For more information on system-defined roles, see the *Data Archive Administrator Guide*. For more information on importing metadata, see the *Enterprise Data Manager Guide*.

Encryption User Role

To run the new Encrypt Data in Data Vault standalone job, a user must have the encryption user role. This role is assigned to the Administrator user by default, both in upgrades to version 6.4.4 and new installations. For more information on system-defined roles, see the *Data Archive Administrator Guide*. For more information on the Encrypt Data in Data Vault job, see the *Data Archive User Guide*.

Enterprise Data Manager

This section describes new features and enhancements in the Enterprise Data Manager for version 6.4.4.

Enhanced Import and Export

Entity-level support for enhanced export and import has been added in version 6.4.4. You have the option to override existing entities when you import, provided the entities are not used in any project definition or discovery operation.

Live Archive

This section describes the new features and enhancements for live archive for version 6.4.4.

Integrated Validation

When you archive data to the Data Vault, you can enable integrated validation for live archive projects. Previously, you could only enable integrated validation on retirement projects. Integrated validation for live archive is available only for Oracle sources.

Informix Source Connections

An option to specify the "delete commit interval" has been introduced for Informix sources in an archive project.

File Archive Transaction Restore API

You can run a transaction restore from the file archive (Data Vault) back to the source database through an external application. You use a specially formatted URL to give the job parameters and call the API. When called, the API immediately starts the file archive transaction restore job in Data Archive. The API uses the parameters that are specified in the URL to run the transaction restore.

Standalone Jobs

Encrypt Data in Data Vault Job

The Encrypt Data in Data Vault job is available in version 6.4.4. This job encrypts data in the Data Vault that was originally archived or retired as unencrypted. You can also run this job on encrypted data to rotate encryption keys at regular intervals, if company security policy dictates the rotation of encryption keys.

Reindex on Data Vault Job

A new standalone job called Reindex on Data Vault is available. The job runs the Delete Indexes on Data Vault and Create Indexes on Data Vault jobs back-to-back, so that you do not have to run the jobs separately.

If you update the legal hold on Data Vault records or perform some operation that updates the rowID, the record details may not be visible when you use keyword search in Data Vault. Use the Reindex on Data Vault job to reindex an archive folder for Data Vault keyword searches, so that you can view the details of each record.

For more information on the Reindex on Data Vault job, see the Data Archive User Guide.

Delete Indexes on Data Vault Job

The Delete Indexes on Data Vault job includes two new optional parameters, "entity" and "table." You can select a specific entity or table to delete indexes on. For more information, see the Data Archive User Guide.

Restore External Attachments from Archive Folder Job

The Restore External Attachments from Archive Folder job has been enhanced. The job includes new parameters that allow you to override any existing source files upon restore, pause the job after the attachments are restored, or purge the attachments from Data Vault after they are restored to the source database.

Update Retention Policy Job

The Update Retention Policy job is enhanced to apply or update the retention policy to the reference tables. Select the **Include Reference Tables** checkbox on the **Manage Retention** page to apply retention to the reference tables. For more information, see the *Data Archive User Guide*.

Run Update Retention JSP

The parameter "IS_INCLUDE_REFERENCE_TABLES" is added to the Run Update Retention JSP. Use the parameter in the URL that calls the JSP to apply or update retention to the reference tables. Valid inputs are Yes and No. The default value is No. For more information, see the *Data Archive Administrator Guide*.

Browser Support

Microsoft Edge

You can use the Microsoft Edge web browser to access the Data Archive user interface. Data visualization is not supported on the Microsoft Edge browser.

System Configuration

Conf.properties File

Effective in version 6.4.4, you can specify whether to sign JAR files that use the time stamp server by enabling or disabling the **informia.useTimestampServerForJARSigning** property.

JDBC Connections in Data Vault with SSL Enabled

Support for SSL through a JDBC URL has been added.

Passwords that contain either of the characters "=" or "," must have the password parameter enclosed in double quotation marks. For more information, see the *Data Vault Administrator Guide*.

The ssacleanup utility includes support for cleanup of offline data files. For more information, see the Data Vault Administrator Guide.

Maximum Number of Legal Holds

An optional parameter called "MAXNUMLEGALHOLD" is available for use. You can add the parameter to the COMMON section of the ssa.ini file to set the maximum number of legal holds allowed per table. By default the maximum number of legal holds allowed per table is 256, but you can configure the parameter up to 16384. For more information, see the *Data Vault Administrator Guide*.

Agent Log File Size

An optional parameter called "AGENTLOG_FILESIZE" is available for use. You can add the parameter to the AGENT section of the ssa.ini file to set the maximum size of a single agent log file in megabytes. For more information, see the *Data Vault Administrator Guide*.

Enterprise Data Manager

Enhanced Import and Export

When you use enhanced import to import metadata in Enterprise Data Manager, the option "commit after each file" has been disabled.

A check has been implemented to verify that XML files exported in one version of Data Archive are imported in the same version.

A check has been implemented to restrict the enhanced import of any files generated using traditional export.

When you upgrade to version 6.4.4, existing users will not be able to import metadata or accelerators unless the user is assigned the Import Metadata role.

Traditional Metadata Import

New Features and Enhancements for Version 6.4.3 HotFix 1

Salesforce Archiving

The new Data Archive Salesforce Accelerator allows you to create connections to Salesforce and archive Salesforce data.

The Salesforce accelerator contains two standard entities, the Task and Event entities. You can configure these entities as well as create custom entities in the Enterprise Data Manager after you install the accelerator. For more information about the Salesforce entities and entity tables, see the *Data Archive Enterprise Data Manager Guide*.

After you create a connection to Salesforce and run a project to archive Salesforce data, you can use standard Data Archive features like compliance features, Data Discovery, and Data Visualization on the Salesforce data.

The Salesforce accelerator is licensed separately from Data Archive and you must install the accelerator after you install or upgrade Data Archive. For more information about the Salesforce accelerator, see the *Data Archive User Guide*.

Salesforce archiving does not support the restore functionality.

Security

Transport Layer Security (TSL1.2) in Data Vault

Security in Data Vault has been upgraded to use TLS1.2 and server certificate validation to make secured connections.

System-Defined Roles

Migration Administrator

A new system-defined role, migration administrator, is available. A user with the migration administrator role can run and monitor and progress of the standalone jobs required for the application migration process, such as the Export Informatica Data Vault Metadata job, Migrate Data Archive Metadata job, and Import Informatica Data Vault Metadata job. For more information on the application migration process, see the Data Archive User Guide.

Healthcare Metadata Administrator

A new system-defined role, healthcare metadata administrator, is available. A user with the healthcare administrator role can view, edit, and create the materialized views used for patient information reports in the Patient Archives. This role is applicable to users who have installed the Application Retirement for Healthcare accelerator. For more information, see the *Application Retirement for Healthcare Accelerator Reference*.

Data Discovery Portal

This section describes new features and enhancements for the Data Discovery Portal in version 6.4.3 HotFix 1.

Saved Criteria

When you search within an entity in Data Vault, you can save the search conditions that you create to be used in future searches.

Saved criteria is useful when you configure multiple search conditions and want to search using the same conditions in the future. You can edit and delete the saved criteria, and you can designate whether the criteria is available for use by all users or only you. For more information about saved criteria, see the *Data Archive User Guide*.

Accelerators

Application Retirement for Healthcare Accelerator

An enhancement to the Application Retirement for Healthcare Accelerator allows you to view and edit materialized view definitions, and create the materialized views in Data Vault, from within the Data Archive interface. This eliminates the previous requirement to view and edit the materialized view statements in the Enterprise Data Manager and run the Create Materialized Views standalone job. In the new healthcare metadata user interface, you can also view a graphical representation of the views required for each report, and the relationships between the views.

Application Retirement

This section describes updates and changed behaviors to application retirement for version 6.4.3 HotFix 1.

Application Migration

The application migration process is an alternative way to complete the retirement process on a production environment, without having to repeat the entire retirement process that you configured and ran on a preproduction environment. Specifically, the migration process directly migrates the entire retired application from the pre-production to production environment.

Data Vault

This section describes new features and enhancements for the Data Vault in version 6.4.3 HotFix 1.

Bulk File Uploader

A bulk file uploader to the Data Vault is available. The bulk file uploader loads extracted flat files (BCP, CSV) to the Data Vault using a lightweight loading mechanism. The bulk file uploader requires that you provide the table attributes in an XML file.

You can use the bulk file uploader when you want to archive large amounts of data to the Data Vault, or when you need to archive data faster than the standard Data Archive process.

The bulk uploader contains the following components:

Ssaservice

Reads the metadata in XML format and schedules jobs.

Ssamon

Monitors and reports the job status.

Addjob

Provides an external way of scheduling standalone jobs.

Standalone Jobs

Application Migration Jobs

The application migration process involves three new standalone jobs.

Export Informatica Data Vault Metadata Job

The Export Informatica Data Vault Metadata job exports Data Vault metadata files, including run-time files, a log file, and a .tar file, to a temporary directory that you specify.

Migrate Data Archive Metadata Job

The Migrate Data Archive Metadata standalone job migrates the Data Archive metadata, including source connections, target Data Vault connection, roles, application and data model metadata, labels, retention, and more to the ILM repository of the target Data Archive system.

Import Informatica Data Vault Metadata Job

The Import Informatica Data Vault Metadata job imports metadata to the target Data Vault instance and registers the SCT files.

Refresh Schema for Salesforce Job

The Refresh Schema for Salesforce standalone job refreshes the Salesforce metadata in the local driver database and is required if the Salesforce metadata has changed since the creation of the source connection. This job applies to users of the Salesforce accelerator.

SSL in Ssa.ini File

The "SSL=1" flag in the ssa.ini file is obsolete due to implementation of TLS1.2. Previously, setting SSL=1 in the [SERVER] section of ssa.ini encrypted the Data Vault data. In version 6.4.3 HotFix 1 and later, this setting has no impact on encryption. Data will not be encrypted if SSL=1 remains in the ssa.ini file.

The SSL flag in the [COMMON] section of the ssa.ini file, which was previously required for the Data Vault Data Archive plugin, is also obsolete.

Single Sign-On Support

Data Archive supports single sign-on through any identity provider that uses the SAML standard. For more information, see the *Data Archive Administrator Guide*.

Data Vault Encryption

Encryption in the Data Vault has been enhanced. When you create a target connection for an archive or retirement project, you can specify how an encryption key is created, either by a random key generator shipped with Data Archive or a third-party key generator. The encryption key is unique to the target connection.

You can also specify an encryption key at the definition level, when you create an archive or retirement project. The key is unique to the archive or retirement definition. For more information, see the *Data Archive User Guide*.

Encryption does not use the CRYPTOKEY and CRYPTOLEVEL parameters in the *ssa.ini* file in the server and plugin.

If you are upgrading to Data Archive version 6.4.3, data that you have previously archived or retired to Data Vault is not affected by this change.

Data Vault Access Roles

The following access roles have been added:

Healthcare Management Information User

The healthcare management information user role has the following privileges:

- Access the Release of Information form in the Application Retirement for Healthcare Accelerator.
- Submit the Release of Information form.

Retention Viewer

The retention viewer role has the following privileges:

- Perform data discovery searches (Browse Data and Search within an Entity in Data Vault) based on retention policy and retention expiration date.
- View retention policy details (retention policy and expiration date).
- View table data.

In order to export data from a search, this role must be coupled with the export administrator role.

Data Discovery Portal

Keyword Search

S3 Storage

The row count summary report is a summary of the Data Vault Loader job, and lists each table loaded to the Data Vault along with their source row count, Data Vault archive folder row count, and any discrepancies. If the Data Vault Loader job loads multiple entities, the summary report contains the consolidated row count of all tables across the entities. When you retire an application to the Data Vault, you can enable integrated validation to ensure the integrity of the retired data. Integrated validation helps you to identify data that might have been deleted, truncated, or otherwise changed during the retirement process.

Before you retire the application, the validation process calculates a row and checksum value for each row and column in the retirement entity. After the retirement job copies the tables to the Data Vault, it calculates a second checksum value for each row and table that has been copied to the Data Vault. The validation process then compares the original checksum values to the checksum values calculated within the Data Vault.

You can review any deviations between the two checksum values. You can also generate a validation report to review the details of the deviations.

SAP Application Retirement

FTP Option

You can use FTP to transfer attachments and the data in cluster and pool tables from the file system on the SAP application server to the Data Archive staging area. Informatica recommends this option.

To use the FTP option, install the FTP server in the same location as the Data Archive staging area. Then, specify FTP connection details such as location and log-in credentials in the source connection parameters.

When you retire an SAP application, Data Archive first moves the files of data and attachments to the file system on the SAP application server. Then, Data Archive pushes the files and attachments to the FTP folder.

If the FTP connection fails during file transfer, Data Archive tries to reconnect three times. If Data Archive fails to reconnect on the third attempt, the retirement project fails. If the connection is reestablished, you can resume the job. The job resumes the load process from the point after the last package was successfully loaded.

To query a metadata column, you must access the Data Vault through a JDBC connection. Add the HIDEMETAFIELDS parameter to the JDBC URL and set it to 0. Use the following syntax:

jdbc:infafas://<host name>:<port number>/sds?HIDEMETAFIELDS=0

Previously, you could not access the metadata columns in tables archived to the Data Vault.

Audit Log

Effective in version 6.3, you can copy specific column values to a CSV file. To copy column values, you use the LOG modifier at the end of the UPDATE and PURGE TABLE commands.

UPDATE

You can copy specific column values to a CSV file. The column values that you can copy are for the rows that you want to put on legal hold with the UPDATE command.

Use the following syntax:

```
UPDATE <table-name> FROM FILE 'update-file-path' [LOG {col1,... colN} INTO
'CSV_file_path';
```

PURGE TABLE

You can copy specific column values to a CSV file. The column values that you can copy are for the rows that you want to physically delete with the PURGE TABLE command.

Use the following syntax:

PURGE TABLE <table-name> [LOG { col1,... colN} INTO 'CSV file path';

Limit Rows in Query Results

Effective in version 6.3, when you connect to the Data Vault through a JDBC or an ODBC connection, you can limit the number of rows in the query results. For example, you might want to see a few rows in the results to verify that a query generates the results correctly.

To limit the number of rows in the results, add the LIMIT condition to the SELECT statement.

Use the following syntax:

<SELECT statement> LIMIT <maximum number of rows in the results>;

Example:

The following statement limits the results to the first 5 rows of the Accounts table.

SELECT col1, col2 FROM Accounts LIMIT 5;

Previously, you could use the LIMIT function only if you connected to the Data Vault through the ssasql Command Line Program.

If you select a future date, the report lists the number of records that will be available for purge by that date. The job stops after it generates the report. You cannot run the job to purge records.

Previously, you could not specify a date for the report. The report was based on the day you ran the Purge Expired Records job. You could not generate a report based on a past date or a future date.

Name of Approver

Effective in version 6.3, to purge records in the Data Vault, you must enter the name of the person who approved the purge before you run the Purge Expired Records job.

Previously, you did not have to enter the name of the person who approved the purge job.

Valid inputs are ASCII and UTF-8. When set to ASCII, the IDVCHARSET parameter sets ASCII mode and treats source data as sets of bytes in the range of 0x00-0xFF.

Example: IDVCHARSET=ASCII

SSL

The SSL parameter gives you the option to enable Secure Sockets Layer (SSL) encryption for the communication between the Data Vault Service, Data Vault Agent, Data Vault Administration Tool, and the ODBC or JDBC application.

To enable SSL encryption, set the SSL parameter in the SERVER section of the ssa.ini file to 1. If you do not want SSL encryption, set the value to 0.

Example: SSL=1

Metadata

You can use the SELECT statement to access virtual tables that contain metadata information. These virtual tables reside in a virtual schema named ADMIN_SCHEMA. The ADMIN_SCHEMA schema resides in the metadata database in the Data Vault.

Use the following syntax to access a virtual table:

```

EXPIRED BY

To delete specific records from a table based on the value in a column, add EXPIRED BY <column name> to the DELETE FROM command.

Use the following syntax:

DELETE FROM <table-name> EXPIRED BY <column-name>;

FROM FILE

To update a table, add FROM FILE 'update-file-path' to the UPDATE command.

Use the following syntax:

UPDATE <table-name> FROM FILE 'update-file-path';

PURGE TABLE

To physically delete the rows that were logically deleted by the DELETE FROM <table-name> EXPIRED BY command, use the PURGE TABLE command.

Use the following syntax:

PURGE TABLE <table-name>;

Data Discovery Portal

Search Options

Effective in version 6.2 HotFix 1, you can specify search options for a child table.

Previously, you could specify search options for a child table only after you specified search options for the parent table.

Search Within an Entity in Data Vault

Effective in version 6.2 HotFix 1, the Search Within an Entity in Data Vault component has the following changes.

 You can specify the format for a column with date values. You specify the format from the Administration
 System Profile menu. The date format applies to the data discovery search criteria and search results. Previously, when you specified the format, the format applied only to the search results, not the search criteria.

Technical View

Effective in version 6.2 HotFix 1, the technical view has the following changes.

• The technical view for the audit log displays the primary keys of the driving table. Previously, the technical view for the audit log displayed the unique row ID of the record. Based on the records selected in the child table, the corresponding records in the reference table appears in the technical view.
 Previously, irrespective of the records you select in the child table, all the rows in the reference table

Data Visualization

appeared in the technical view.

Effective in version 6.2 HotFix1, the data visualization component has the following changes:

- If a table name or column name starts with a number, then Data Archive adds the prefix INFA to the name
 in the report-creation wizard. For example, if the column name is 34_REFTABLE_IVARCHAR, then the column
 name appears as INFA_34_REFTABLE_IVARCHAR in the report creation wizard.
 Previously, if a table or column name started with a number, the table or column did not appear in the
 report creation wizard.
- If a column name contains a special character, Data Archive replaces the special character with an underscore when the column name appears in the report-creation wizard.
 Previously, if the column name contained a special character, the column did not appear in the reportcreation wizard.
- When you create a report, you can click **Back** to go to a previous step in the report-creation wizard. If you go to back to the **Create Report: Step 2 of 3** step in the wizard, you must enter a new name in the **Data Object Name** field.

Previously, if you wanted to make a change on a previous step, you had to exit the report-creation wizard and start the report creation process again.

Enterprise Data Manager

Entity Name

When you create an entity, Data Archive assigns a name to the entity that is unique across the application version.

Previously, Data Archive assigned a name to an entity that was unique only within an application module. Consequently, an entity could have the same name as an entity in a different application module of the application version.

Automatic Entity Generation

The automatic entity generation component has the following changes:

- If the tables in the entity have self-referential constraints, a warning message appears asking you to verify the constraints. If you continue to create the entity without changes to the constraints, the following limitations might apply:
 - You cannot validate the entity.
 - You can run the archive-only job. You cannot run the archive and purge job.
 - The archive-only job might archive a transaction more than one time.
 - After you archive the entity, you must delete the data from the source database.

- If the archive job created duplicate records, you cannot restore the entity to the source database.

Previously, if the tables in the entity had self-referential constraints, the entity creation component did not generate the correct insert and delete statements.

- If the tables in the entity have multiple parents, a warning message appears asking you to verify the constraints. If you continue to create the entity without changes to the constraints, the following limitations might apply:
 - The archive job might archive a transaction more than one time. This occurs when multiple foreign keys point to the same parent table or the same record has multiple parent tables.
 - If multiple foreign keys point to same parent table, you must delete the data from the source database after you archive.
 - If the archive job created duplicate records, you cannot restore the entity to the source database.

Previously, if the tables in the entity had multiple parents, the entity creation component did not generate the correct insert and delete statements.

In the SQL statement, the first time a table alias name appears, the table alias name is the same as the table name. For subsequent occurrences of the same table name, the automatic entity creation component generates the table alias name in the following format: AZ__<number of occurrence>. This format ensures that the table alias name is unique each time it occurs in the SQL statement. This format also prevents the table alias name from exceeding the maximum number of characters allowed by the database.

Previously, the table alias name was <schema name>_ regardless of the number of times it appeared in the SQL statement. The table alias name could exceed the maximum number of characters than that allowed by the database. Consequently, the archive job failed.

• If the tables in the entity do not have constraints, a message appears letting you know that you must add a primary or unique key to create the entity.

Previously, if the tables in an entity did not have constraints, the entity was created without the constraints. However, you could not save the entity unless you added the insert and delete statements.

Smart Partitioning

Effective in version 6.2 HotFix1, the following changes apply to smart partitioning:

- The step SKIP_UNUSABLE_INDEXES has been added to the session configuration parameters. This may prevent the Get Table Row Count Per Segment job from failing during the split segment creation process.
- The Segmentation tab in the Enterprise Data Manager is static and appears after you log in or refresh.
- You can view the details of the global tablespace after you generate metadata for the segmentation group.

The SAP application accelerator includes Data Visualization report templates. The reports include information that corresponds to key information in SAP ERP transactions. Run the reports to access retired data in the Data Vault.

To narrow search results, you can filter by application, entity, and table. You can generate a technical view to see the table hierarchy of a record. You can also export the search results to a PDF file.

The INDEXDIR parameter specifies the directory where the Data Vault Service stores indexes for data files. The SERVER and QUERY sections include the parameter.

You provide the parameter value when you install the Data Vault. For upgrades, the ssa.ini file includes a default value.

CRYPTOLEVEL and CRYPTOKEY

The CRYPTOLEVEL and CRYPTOKEY parameters determine if the Data Vault Service encrypts temporary staging files. The COMMON section includes the parameters.

After you install or upgrade, configure the parameter to enable encryption.

Data Indexing

You can create and manage indexes on tables in the Data Vault to increase query performance. The indexes eliminate data files that do not meet the query WHERE clause filters. The indexes also help to increase the performance of row selection for columns in the WHERE clause filter.

You can create, alter, drop, and renew the indexes. You configure the directory for the index files when you install the Data Vault. When you upgrade, the installer adds the default index file directory to the ssa.ini file.

The generate metadata for segmentation group step of the smart partitioning process copies the context attribute values vpd context namespace and vpd context attribute from the tdi_all_configs table.

When you upgrade, the files in the previous directory remain unchanged. The Data Vault Service uses the new directory for any files that it creates after the upgrade.

Connectivity

Effective in version 6.2, client tools that use JDBC drivers to the connect to the Data Vault must use JDBC driver type 4.

If you use JDBC client tools to query data from the Data Vault, such as a SQL tool or a third-party reporting tool, you must update the JDBC connection URL.

Use the following syntax for the JDBC connection string:

jdbc:infafas://<Data Vault administrator user>@<Data Vault hostname>:<Data Vault port>/
<Data Vault database name>
```

Where

- Data Vault administrator user is the name of the default administrator user account that the client tool uses to connect to the Data Vault Service.
- Data Vault hostname is the name or IP address of the machine on which the Data Vault Service runs.
- Data Vault port is the port number of the machine that hosts the Data Vault Service.

• database name is the Data Vault database that contains the archived data. The database name is equivalent to the archive folder in Data Archive.

The following URL is an example of the required syntax for the JDBC connection string:

jdbc:infafas://dba@infa-server:8500/OPEN MRS

Previously, the Data Vault supported JDBC driver type 2 connections with JDBC-based client tools.

Data Partitioning

Effective in version 6.2, you can re-partition archived data directly in the Data Vault to improve query performance and to free resources.

Previously, to use a different characteristic to partition data files, you restored the archived data to the source database. Then, you archived the data with the new characteristic and registered the data files in the Data Vault repository.

Data Vault Migration

Effective in version 6.2, you cannot migrate data directly from File Archive Service 5.3.x to the Data Vault. The following jobs are deprecated:

- File Archive 5.3.x Table List for Migration to Optimized File Archive
- File Archive 5.3.x to Optimized File Archive Data Migration

You can search the file archive based on columns in a reference-table. To search for data using a reference-table column, select the reference table and its columns from the Search Options page.

Date-Format Conversion

You can use the Gregorian-format to search for data based on dates, even if the date field has a Julian format. To enable this, you must select the data-conversion option on the Search Options page.

Number of Rows in Technical View

You can configure the maximum number of rows to display for each child table in the Search File Archive technical view by configuring the informia.techViewMaxDisplayRowCount property in the conf.properties file.

Datatype Mapping

Audit Logs

If you configure the audit level to Audit Metadata Modifications, the audit logs captures information when a job runs. The audit log displays information such as the user ID of the person who starts the job, the name of the job, the date and time the job starts, and the outcome of the job.

LDAP Authentication

To indicate that all entries in an LDAP security group must be treated as individual users in Data Archive, specify the object class.

Start the Sync with LDAP Server job. Enter a filter value such as ObjectClass=user or ObjectClass=Person in the User Filter field.

If you do not set the user filter correctly, Data Archive will treat the entire LDAP security group as an individual user.

A user with a Report Viewer role alone, cannot log into the Data Archive user interface. Users must have another role such as Archive User to log in.

Smart Partitioning

Smart partitioning is a process that divides application databases into independent, relationally intact partitions called segments. Segments are database partitions with a business definition. Before you implement smart partitioning, you specify high-level business policies based on the application data model. The ILM Engine creates segments based on the dimensions you define in a data classification.

Smart partitioning can help increase application performance by allowing users to access only specific segments. Smart partitioning can also leverage native database technologies to compress segments, resulting smaller storage requirements. Tiered storage and other database optimization techniques are also available.

New Features and Enhancements for Version 6.1

This section describes the new features and enhancements for version 6.1.

Application Retirement

This section describes the new features and enhancements for application retirement for version 6.1.

SAP Application Retirement

- You can retire SAP applications that are hosted on IBM DB2, Informix, and Sybase databases.
- You can retire SAP applications that are hosted on any operating system that SAP supports.
- You can archive data stored in SAP Archiving files (ADK files). The retirement job uses the SAP Java Connector to log in to the SAP application and to call an ADK function module. The function module reads and extracts the archived ADK data and moves to the BCP staging area as compressed BCP files.
- The Enterprise Data Manager includes a new application for SAP. The application has application modules for CRM, ERP, and SRM. The application modules include pre-packaged entities for the Human Resources PCL1-PCL5 cluster tables, the STXL text table, and attachments. Use the entities for data extract in retirement projects. The entities are not available for Data Discovery

portal searches as the entities do not include constraints.

- You can retire ERP, SCM, and SRM attachments.
- You can configure if you want to move attachments that are stored in an external file system to the file system staging area. The run procedure parameters for the pre-packaged attachment entity control if the retirement job moves attachments that are stored in an external file system.
- The Import Metadata job imports metadata directly from all SAP tables in the database, including pool and cluster tables. The job includes a new parameter to indicate if the source is an SAP application. When you indicate that the source is an SAP application, the Import Metadata job runs steps that are specific to SAP applications.

- The Enterprise Data Manager includes new SAP-specific table types. The Import Metadata job automatically adds the table types to the corresponding table metadata in the ILM repository. The Retirement Entity Creation job uses the table types to determine which tables and entity default steps to add to the entities.
- Oracle, Microsoft SQL Server, IBM DB2, Informix, and Sybase source connections include SAP-specific connection properties. The retirement job uses the connection details to log in to the SAP application. You configure the source connection for the database that hosts the SAP application.
- The File Archive Loader job loads .gz files.
- The retirement job log shows all messages related to the retirement process. Any messages that the SAP
 application generates are written to the retirement job log.
- The conf.properties file includes the informia.isSapOnWindows property for SAP application retirement. The property determines if an additional row separator is required for BCP file generation when the retirement job uses an SAP function module to generate BCP files for data in transparent HR and STXL tables, ADK files, and attachments. Configure the property if the SAP application is hosted on Windows.

The new features are available for File Archive Service version 6.1.

z/OS Source Data Retirement

You can connect to a z/OS data source through PowerExchange ODBC drivers in order to retire non-relational mainframe data such as IMS or VSAM source data. Data Archive uses a JDBC-ODBC bridge to connect to the z/OS source through PowerExchange ODBC drivers.

Teradata

- You can use Teradata Parallel Transporter to export data from Teradata sources on Linux to the optimized file archive. Teradata Parallel Transporter is the fastest method for data movement and can drastically improve the performance of the Copy to Destination step of archive and retirement jobs. You configure the Teradata source connection to use Teradata Parallel Transporter. The Teradata Parallel Transporter client must be installed on the same machine that hosts Data Archive. This feature is available with File Archive Service version 6.1.
- You can configure Teradata Parallel Transporter to create compressed or uncompressed BCP files. The File Archive Loader job is enhanced to load uncompressed BCP files to the optimized file archive.
- The Copy to Destination log in the archive and retirement job is enhanced to show the utility that the job uses to extract data from Teradata sources.

ILM Discovery Option

You can discover table relationships from data stored in the optimized file archive. You may need to discover table relationships from the optimized file archive if the source database is no longer available.

You can invoke Informatica Data Explorer to connect to and run the table relationship discovery on the optimized file archive. Alternatively, you can generate profiles for the optimized file archive within Informatica Data Explorer and import the profiling results.

You use the discovered table relationships to create constraints for the source metadata in the ILM repository. Then, you can use the constraints to create data discovery entities.

Metadata Import

- The Import Metadata job performance has dramatically increased when you import metadata as a background job.
- After you import metadata as a background job, you can refresh the Enterprise Data Manager to see the list of imported tables.

File Archive Service

This section describes the new features and enhancements for the File Archive Service in version 6.1.

- The File Archive Service has a File Archive Service Agent component to process client requests. You can install multiple instances of the File Archive Agent on different machines. The File Archive Service has a load balancer that sends client requests to the first available File Archive Service Agents for processing.
- When you install the File Archive Service Agent on multiple machines, the File Archive Service Agent can access the data through the Network File System (NFS) protocol. The File Archive Service Agent does not require a clustered file system.
- You can use one instance of File Archive Service to archive data to multiple external storage platforms. Additionally, you can now archive to the following storage platforms:
 - Hadoop Distributed File System (HDFS)
 - Hitachi Data Ingestor (HDI)
- The File Archive Service has improved query and load performance.

Retention Management

This section describes the new features and enhancements for retention management for version 6.1.

Legal Hold

- You can apply or remove legal hold at the application level.
- You can apply or remove legal hold for entities that are unrelated.

Purge

You can apply or remove a purge job for entities that are unrelated.

Retention Policies

- You can apply or remove retention policies for entities that are unrelated by using an absolute-date based retention.
- You can base a retention policy on an entity tag value by using expression based retention.
- For unrelated entities, you can view the impact of an intended retention policy on the application, schema, and tables by reviewing the unrelated-entity-retention report.

Tags

- You can search for records based on tags defined in the child tables.
- If you have the appropriate user privileges, you can view the values in the tag columns. From the UI, go to **Data Discovery** and select **Browse Data**.

Updates and Changed Behavior for Version 6.1

This section describes the updates and changed behavior for version 6.1.

Connections

Effective in version 6.1, you can use Teradata Parallel Transporter to export data from Teradata sources on Linux to the optimized file archive. You configure the Teradata source connection to enable Teradata Parallel Transporter.

Previously, all archive and retirement jobs used Teradata JDBC FastExport to export from Teradata to the optimized file archive.

Enterprise Data Manager

Effective in version 6.1, after you import metadata as a background job, you can refresh the Enterprise Data Manager to see the list of imported tables.

Previously, after you imported metadata as a background job, you had to close and open the Enterprise Data Manager to see the list of imported tables.

File Archive Service

This section describes the updates and changed behavior for the File Archive Service in version 6.1.

Architecture

Effective in Data Archive 6.1, the File Archive Service has a new architecture that is not compatible with the File Archive Service in previous versions of Data Archive.

You can continue to use File Archive Service 5.3.x after you upgrade to Data Archive 6.1. However, Informatica will discontinue support for File Archive Service 5.3.x in the near future. To maintain full support, Informatica recommends that you move to File Archive Service 6.1 as soon as possible.

File Archive Service Plug-In

Effective in version 6.1, when you install the File Archive Service and Data Archive on different machines, you install a File Archive Service plug-in on Data Archive machine. You do not need to copy the files of the File Archive Service web tier to the Data Archive machine. You use one URL to access the File Archive Service and Data Archive.

Previously, after you installed the File Archive Service and Data Archive on different machines, you needed to copy the File Archive Service web tier to the Data Archive machine. You used different URLs to separately access the File Archive Service and Data Archive.

File Archive Service Scalability

Effective in version 6.1, you can install a File Archive Service Agent on multiple machines and use the Network File System (NFS) protocol to access the File Archive Service Agent on each machine.

Previously, the File Archive Service did not include a File Archive Service Agent component. If you installed the File Archive Service on multiple machines, you had to use a clustered file system to access each File Archive Service instance.

Multiple ILM Engines

Effective in version 6.1, you do not have to share the ILM_HOME/webapp/file_archive/ directory between multiple ILM engine instances, even when the File Archive Service and the ILM engines are on the same server. Previously you were required to create symbolic links to the ILM_HOME/webapp/file_archive/ directory for each ILM engine you used to archive data to the optimized file archive.

UTF8 Encoded Table and Column Names

Effective in version 6.1, you can archive tables with UTF8 encoded metadata.

Previously, you had to modify the File Archive Service metadata xml file before you could archive tables with UTF8 encoded table and column names.

Archive Storage

Effective in version 6.1, you can use one instance of File Archive Service to archive data to multiple external storage platforms.

Previously, you needed multiple instances of the File Archive Service to archive data to multiple external storage platforms.

Retention Management

This section describes the updates and changed behavior for retention management in version 6.1.

Legal Hold

Effective in version 6.1, the performance and scalability of the legal hold functionality has been improved in the following ways:

- You can resume a legal hold job from the point of failure. Previously, when you resumed a legal hold job, the job restarted.
- The query construction for legal hold is optimized. Child tables have a metadata column, either a tag or legal-hold column, that gets populated with the attribute applied to the parent. This allows the query to construct a join of just the child and immediate parent.

Previously, the query constructed a join that included the child, immediate parent, grandparent, and beyond. This strategy did not successfully scale to more than seven or eight levels.

Note: Legal hold at the application level and unrelated-entity level does not depend on the relationship between tables. Because of this, any relation-based search or navigation on unrelated entities is not supported.

Purge

Effective in version 6.1, the performance and scalability of a purge job has been improved in the following ways:

- You can resume a purge job from the point of failure. Previously, when you resumed a purge job, the job restarted.
- A new optional parameter called Entity, has been added to the Purge Expired Records job. You can select an entity from the Entity list-of-values window to limit the purge process to an entity in the archive folder. Previously, you could narrow the scope of a purge job to all entities you had permission to access.
- The retention-expiration date is applied to individual tables when a retention policy is applied. Purge jobs are executed more quickly because there is no need for the retention status of individual child records to be first evaluated.

Previously, the retention-expiration date was set at the driving table. When a purge job was scheduled, the retention status of each child record would be evaluated.

Retention Policies

Effective in version 6.1, the performance and scalability of applying retention policies have been improved in the following ways:

- You can resume the application of a retention policy from the point of failure. Previously, when you resumed the application of a retention policy, the job restarted.
- The query construction for a retention policy is optimized. Child tables have a metadata column, either a
 tag or legal-hold column, that gets populated with the attribute applied to the parent. This allows the query
 to construct a join of just the child and immediate parent.
 Previously, the query constructed a join that included the child, immediate parent, grandparent, and

beyond. This strategy did not successfully scale to more than seven to eight levels.

Note: Applying a retention policy at the application level and unrelated-entity level does not depend on the relationship between tables. Because of this, any relation-based search or navigation on unrelated entities is not supported.

SAP Application Retirement

This section describes the updates and changed behavior for SAP application retirement for version 6.1.

Prepare SAP for Retirement Job

Effective in version 6.1, the Prepare SAP for Retirement job is deprecated. The physical database preparation of special SAP tables is no longer required. Special SAP tables are pool tables, cluster tables, transparent HR tables, transparent STXL table, tables that store data in SAP encoded format, and attachments.

The Import Metadata job and the retirement jobs changed to perform the necessary steps to retire an SAP application. The Import Metadata job reads metadata directly from the SAP database. During the extraction process, the retirement job logs in to the SAP application to process data for tables that need special processing.

Previously, you ran the Prepare SAP for Retirement job before you imported metadata from the SAP database. The Prepare SAP for Retirement job created physical tables for SAP tables that require special processing. After the job created the physical tables, the job copied the table data from the original table to the physical tables. Then, you could import metadata from the physical tables and retire the data from the physical tables.

Staging Space

Effective in version 6.1, the SAP Retirement Staging Requirements job is deprecated. Staging space on the database is no longer required.

Previously, you needed staging space on the database to store the physical tables that the Prepare SAP for Retirement job created.

Import Metadata Job

Effective in version 6.1, when you import metadata from SAP applications, you do not have to exclude any tables.

Previously, you used a regular expression to exclude tables that had a slash (/) in the table name.

XML Transformation of SAP Encoded Data

Effective in version 6.1, the retirement job transforms SAP encoded data into XML format for the HR PCL1-PCL5 cluster tables and the STXL text table. The retirement job logs in to the SAP application to read and decode the SAP encoded data during the extraction process. No temporary storage is required for the XML transformation.

Previously, the Prepare SAP for Retirement job created physical tables for all tables that store data in an SAP encoded format. This step was required because you can only read the SAP encoded data through the SAP application layer. The job logged in to the SAP application to read the encoded data, transform the encoded data into XML format, and copy the transformed data to the physical table that the job created.

Retirement Job

Effective in version 6.1, the retirement job uses the SAP Java Connector to log in to the SAP application to archive data from attachments, ADK files, and special tables. Special tables are pool tables, cluster tables, transparent HR tables, and tables that store data in SAP encoded format.

For special tables that require additional processing, such as pool tables, cluster tables, transparent HR tables, and tables that store data in an SAP encoded format, the retirement job uses the SAP Java Connector to log in to the SAP application and to call a function module. The function module reads, decodes, and extracts the data from the tables and moves the data to the BCP staging area as compressed BCP files.

Previously, the Prepare SAP for Retirement job used the SAP Java Connector to log in to the SAP application and to prepare the special tables. The job converted the data to a staging space. The retirement job archived all data directly from the database without logging in to the SAP system.

Attachment Processing

Effective in version 6.1, the retirement job processes attachments. The retirement job logs in to the SAP system to read and decode the attachments that are stored in the SAP database. Then, the job compresses the attachments in gzip format to the attachment staging area. Depending on your configuration, the retirement job can also move attachments that are stored in an external file system to the attachment staging area.

Previously, the Prepare SAP for Retirement job processed attachments. The job downloaded and compressed all attachments to a an attachment staging area. For attachments that are stored in an external file system, the job moved the attachments from the file system to the attachment staging area. For attachments that are stored in the SAP database, the job decoded the attachments and moved the attachments to the attachment staging area.

Attachments in External File Systems

Effective in version 6.1, it is not mandatory to move attachments that are stored in an external file system to the attachment staging area. The run procedure parameters for the attachment entity controls whether the retirement job moves attachments that are stored in an external file system. Because the attachment entities are standard, you must copy the entity before you make changes.

You can leave the attachments in the external file system. Or, you can move the attachments to the attachment staging area. You need to move the attachments to the attachment staging area if you want to archive the attachments to the optimized file archive or to third party storage such as Enterprise Vault.

Previously, the Prepare SAP for Retirement job moved all attachments that are stored in an external file system to the attachment staging area.

SAP Database Connection Attributes

Effective in version 6.1, Oracle, Microsoft SQL Server, IBM DB2, Informix, and Sybase source connections include SAP-specific properties. You configure properties to connect to the SAP application and the location of the attachment staging directory. The retirement job uses the connection details to log in to the SAP application. The retirement job logs in to the SAP application to read and transform SAP encoded table data, to move attachments that are stored in the SAP database, and to archive ADK files.

Previously, you provided the connection details and attachment staging directory in the Prepare SAP for Retirement standalone job.

SAP GUID Columns

Effective in version 6.1, the SAP GUID columns are created as VARCHAR datatype.

Previously, the SAP GUID columns were created as BLOB datatype.

Security

This section describes the updates and changed behavior for security for version 6.1.

Users

Effective in version 6.1, you can connect to the ILM repository with a user name that is different from the schema name that owns the tables.

Previously, you could use different user and schema names to connect to the source repository. However, to connect to the ILM repository, you could only use the repository schema name.
