Support Changes

Oracle Database 19c Support

Oracle Database 19c is supported for Multidomain MDM 10.3 HotFix 3.

Deprecated Support for Adobe Flash Player

Effective in version 10.3 HotFix 3, Informatica Data Director with subject areas does not require Adobe Flash Player.

Support for Adobe Flash Player is deprecated. Adobe announced that it would end support for Flash Player at the end of 2020.

Deprecated Support for Informatica Data Controls

Effective in version 10.3 HotFix 3, support for Informatica Data Controls (IDC) for Data Director with subject areas is deprecated. Informatica intends to drop support for IDC in future releases.

Migrate Bundle

In the Data Director Configuration Manager, the migrate bundle localizes the metadata of records that belong to a subject area and are migrated to business entity records.

Hub Server Properties

You can use the following Hub Server property to control the run-time behaviour of the MDM Hub:

cmx.e360.submit_all

Optional. Specifies whether Data Director must submit all the fields to the Hub Server for validation and save the edits to any field of a business entity record. Default is false.

Configure the Hub Server properties in the cmxserver.properties file.

Elasticsearch Installer

Effective in version 10.3 HotFix 3, you must download the supported version of the Elasticsearch installer from the Elastic website.

Previously, the Elasticsearch installer was included in the Multidomain MDM installer package.

Support for Elasticsearch 6.8.6

Effective in version 10.3 HotFix 3, the search operation requires Elasticsearch version 6.8.6.

History View

Effective in version 10.3 HotFix 3, Data Director has a new user interface for the **History** view and does not require Adobe Flash Player. You can use the **History** view to view the data changes that a record has undergone. Each data changes appears as an event in the **History** view.

The History view does not display the history of relationship records.

Hierarchy View

Fully Qualified Domain Name

For Data Director to connect to the MDM Hub Server, configure the Java Virtual Machine (JVM) by setting the following Java option:

-De360.mdm.host=devazimdpapp2.ksdevx.net

Specifies the fully qualified domain name (FQDN) assigned to security certificates issued to Informatica.

Connection Protocol

For the Entity 360 application to connect to the MDM Hub Server, configure the Java Virtual Machine (JVM) by setting the following Java options:

-De360.connection.channel

Specifies the communication protocol the Entity 360 application uses to communicate with the MDM Hub Server. Specify whether the communication protocol to use is EJB, HTTP or HTTPS. Default is -De360.connection.channel=http. Ensure you set the supporting application server host property -De360.connection.channel=http. Ensure you set the supporting application server host property -De360.mdm.host and application server port property -De360.mdm.port to the default values.

You must set the following application server host and port Java options:

Entity 360 application server host. Specify the host used by the Java option.

You must deploy Multidomain MDM on Red Hat JBoss Enterprise Application Platform (EAP) 7.1. The end of maintenance support by Red Hat for JBoss EAP 6.x is June 2019. Informatica recommends that you upgrade

to JBoss EAP 7.1 and Multidomain MDM 10.3 HotFix 1 for continued support, bug fixes, and security patches from Red Hat. Multidomain MDM 10.3 HotFix 1 does not support JBoss EAP versions earlier than 7.1.

IBM WebSphere Version 9.0 Fix Pack 10 Support

You must deploy Multidomain MDM on IBM WebSphere Application Server Version 9.0 Fix Pack 10. Multidomain MDM 10.3 HotFix 1 does not support WebSphere versions earlier than 9.0 Fix Pack 10.

Red Hat OpenJDK 8 Support for JBoss

You can run Multidomain MDM 10.3 HotFix 1 on Red Hat OpenJDK 8 in a JBoss application server environment.

Provisioning Tool Performance Enhancement

The performance of the Provisioning tool is enhanced by improving the response time. Changes made in the Provisioning tool are saved and published within a minute.

Message Trigger Enhancement

When a cross-reference record is restored, the MDM Hub can trigger a message to be placed in the JMS message queues. To set up message triggers for an event that restores a cross-reference record, use the Schema Manager. In the **Events** section of the **Message Triggers** page, select **Restore**, which is the new event included in the section.

Save Handler User Exit Enhancement

In Save Handler user exits, you can use the getChangedChildren method to return modified or added child or grandchild records in a specified base object.

The user exit returns all records that were added, deleted, or updated. You can select the type of changes returned by the user exit. For example, the user exit can return a combination of removed and updated children records.

Hub Server Properties

You can use the following Hub Server properties to control the run-time behavior of the MDM Hub.

Configure the Hub Server properties in the cmxserver.properties file.

com.siperian.dsapp.mde.common.idd2cocs.Many2ManyChild.name.version

Must be added manually. During an upgrade from a version before 10.3, when MDM administrators generate the business entity schema, the uppercase characters in some child-level subject area names change to lowercase. To preserve the case, set the property to 10.2.

cmx.server.put.autopopulate.missing.user.columns.bo.list

Must be added manually. Set the property when the Nullable property is disabled for the base object columns.

When the Nullable property is disabled for columns, if a record is updated in Data Director or during a SIF PUT operation, a cross-reference record is created with values only for the updated fields. All the other cross-reference record fields, including the fields that must not be null, have null values. During the best version of the truth (BVT) calculation for the record, null values can be the winner for fields that must not be null, and an error occurs.

To ensure that the BVT calculation takes into account the fields that must not be null, set the property value to a comma-separated list of the names of base objects that have columns with the Nullable property disabled. When the property is set, the MDM Hub updates the null values in the cross-reference record with values from the associated base object. This ensures that during BVT calculation, null values are not the winner for fields that must not be null.

cmx.server.enrichcopager.thread_pool

Must be added manually. Sets the number of threads the EnrichCoPager property uses from the thread pool to perform parallel ReadCO operations. Default is 30. If you set the number of threads to 1, the property is disabled.

cmx.server.enrichcopager.min_rec_for_multithreading

Must be added manually. Sets the minimum number of records to return before the EnrichCoPager property uses multithreading. Default is 2.

Global Properties

Java Virtual Machine Settings for Smart Search with Solr (for JBoss)

If you want to configure smart search with Solr for the MDM Hub that you deploy in a JBoss environment, configure the Java Virtual Machine (JVM) by setting the Java options for smart search.

Set the following Java options for smart search:

-Dmdm.ps.zk.node

Required if you want to use smart search with Solr. Set this Java option on the JVM for the Process Server that is intended to be the ZooKeeper server. Set to true.

Dmdm.ps.search.node

Required if you want to use smart search with Solr. Set this Java option on the JVMs for the Process Servers that will have search processing enabled and function as Solr servers. Set it to true.

Dsearch.service.port

Required if you want to use smart search with Solr. Required if you want to install multiple Process Servers on the same machine but on different JVMs and enable smart search on all the Process Servers on the machine. This Java option specifies the port used by the JVM for the search service. To avoid port conflicts, use the default port for the JVM of one Process Server, and set this Java option to the relevant port numbers for the JVMs of the remaining Process Servers.

Search with Apache Solr is Deprecated

Effective in version 10.3, the search functionality in Data Director that used Apache Solr is deprecated. Informatica will drop support for search with Solr in a future release. You can use search with Elasticsearch to find records in Data Director. Elasticsearch is an open-source, full-text search engine.

You must configure search with Elasticsearch, which is packaged with the MDM Hub installer. You can set up Elasticsearch as a single node cluster or as a multi-node cluster to provide distributed indexing and search. For a smooth transition, the APIs that were supported for search with Apache Solr are supported for search with Elasticsearch.

Task Inbox

Effective in version 10.3 HotFix 1, you can filter tasks in the task inbox based on creation date.

Related Records Component

Effective in version 10.3 HotFix 1, in the Provisioning tool, a single Related Records component replaces both the Related Records (Edit Mode) and Related Records (View Mode) components. In the new Related Records component, you can configure whether records open in view mode or edit mode. You can also configure whether the relationship direction is honored.

Previously, you had to chose which component to use. Only the Related Records (Edit Mode) component was configurable. The Related Records (View Mode) component was the default, but it was not configurable and it ignored the relationship direction.

Localization of Data Director

In Data Director with business entities, you can display elements of the user interface in any supported language. As the MDM administrator, you can localize metadata, labels, error messages, and lookup tables. Data Director supports the following languages:

- English US
- English UK
- Portuguese

- French
- Spanish
- German
- Russian
- Japanese
- Mandarin
- Korean

Localizing Metadata

You can localize metadata elements of the Data Director user interface to display the language of your choice. Examples of metadata elements are menu names, field names, tasks and business entity names.

To localize metadata, in the Provisioning tool, download the *besMetadata.properties* zip file and edit the *bundle.properties* file for the language that you want to display. For example, for French localization, edit the *bundle_fr.properties* file. To localize task actions and task types, you must manually edit the values in the *besMetadata.properties* file by using the *taskaction.<action name>* format.

Localizing Label and Error Messages

You can localize labels and error messages of Data Director to display the language of your choice. To localize labels and error messages, you must run the *LocalizationSetup* script from the Resources Toolkit. The script is part of the MDM Hub installation package.

Localizing Lookup Tables

All lookup tables support localization. For example, the Gender, Country, and State lookup tables are mapped to the corresponding Gender, Country and State localization lookup tables.

Record View Layouts

You can design custom record view layouts to replace the **Matching Records** view, the **Hierarchy** view, and the **History** view. You can also replace the layouts for review tasks, merge tasks, and unmerge tasks.

To design a custom view, use the Provisioning tool. Create a record view layout, and specify a name, purpose, and users who can access the custom view. Then add components to the layout to build the custom view.

In Data Director, the custom views appear in the **View** list. The custom views for tasks appear in the Task Manager in Data Director.

In the custom record view for merging duplicate records and viewing record history, you can choose to display either the full business entity or a business entity view, which is a subset of fields from the business entity. Previously, these record views were default views and displayed the full business entity.

You can choose to configure the basic **Matching Records** view or the advanced **Matching Records** view for a business entity. The basic **Matching Records** view lets you merge only the duplicate parent records. The advanced **Matching Records** view lets you merge the duplicate parent and child records. You can configure one or both the **Matching Records** views for your application.

Previously, you could only design custom record view layouts to replace the default entity view.

Hiding the Default Record Views

In the Provisioning tool, you can configure a Data Director application to hide the default record views in the **View** list.

The default record views are enabled by default so that users can view and manage records in Data Director. After you design custom views, you can choose to hide the default record views to reduce confusion for your end users.

Previously, you could not hide the default record views in Data Director.

Note: When you upgrade Multidomain MDM, the View list contains the default record views by default.

Similar Records Component

You can use the Similar Records component to search for similar records when you create new records. You can decide whether you want to use search or queries to display records in the Similar Records component. You can configure exact or fuzzy queries.

Previously, you could only configure search with the Similar Records component.

Matching Records View

The Matching Records view is enhanced to make it easier for you to identify and resolving duplicate records.

The following enhancements are made to the Matching Records view:

You can now perform the following tasks:

- Resolve duplicates using the basic Matching Records view or the advanced Matching Records view. The
 basic Matching Records view lets you merge only the duplicate parent records. The advanced Matching
 Records view lets you merge the duplicate parent and child records. Your can configure Data Director to
 have one or both the Matching Records views.
- Show information that might help you in determining duplicates, such as trust scores, and display only the records that you select for merging.
- View the match rule details for the matching records.
- Use breadcrumbs that are added to the matching records to identify the parent of the records to be merged.
- If duplicate records are missing from the **Matching Records** view, you can manually add the records to the view. To find the records that you want to add, use search or queries.
- Remove records that you do not want to merge or are not duplicates.
- Queue records for an automatic merge.
- Finalize the best version of the truth by promoting or overriding the values that you think are correct.
- Before you merge the records, you can preview the result of merging the records.

Cross-reference Records View

The **Cross-reference Records** view includes breadcrumbs to help you identify the parent records of a crossreference record. The last record listed in the breadcrumbs trail is the immediate parent of the record that is open in the **Cross-reference Records** view.

Task Manager

If you have the ActiveVOS abAdmin role assigned, you can see the workflow details of a task in the Task Manager. You can also assign a task that belong to another user of your user group back to the pool so that a different user can claim it.

Merge Tasks

The reviewer of a merge task can update the merge task during the review process.

In the review panel, reviewers can perform the following actions that are possible in the **Matching Records** view:

- Add duplicate records that you want to merge.
- Remove records that you do not want to merge.
- Finalize the best version of the truth by selecting fields with correct values or by entering the correct values.

Attach Files to Records

When you add or edit a record, you can attach files as the child records to the record. Use the Provisioning tool to configure a business entity field with FileAttachment as the data type. You can then use the business entity field to attach files in a Data Director application.

Attach Files to Tasks

You can attach files to tasks. When tasks are configured to support attachments, you can attach a file to any task that you can view. Files attached to tasks appear in the task details, and user that can view the task can view the attachment.

Comments and Attachments for Tasks

You can configure whether users must add a comment or attachment when they trigger a workflow or perform task actions. To configure the comment and attachment settings, use the Provisioning tool.

Previously, users could add comments to tasks, but you could not require users to add comments.

Workflow Triggers

You can configure a workflow trigger to prompt users for comments, attachments, or both. For example, you can configure the unmerge task trigger so that users must add a comment when they trigger unmerge tasks.

Task Types

You can configure a task type to prompt users for comments, attachments, or both. You can also allow users to attach files from the **Task Details** dialog box. For example, you can configure review tasks so that reviewers must add a comment and attachment when they reject a proposed change to a business entity record. You can configure merge tasks so that reviewers can attach files when they edit the task details.

Security for Business Entities

You can apply MDM Hub user roles to manage access to records based on business entities. You can also use data filters to manage access to records based on the values in the fields and user roles. If you want to restrict the values that can be added to a field, you can create a list of default values for the field.

User Roles and Business Entities

A business entity is a data structure with a root base object and child base objects. When you assign user role permissions to base objects and other resources in the MDM Hub Console, the record views in Data Director inherit the permissions. For example, if you grant the read permission to a user role on the base objects, the user has the same access to business entity records.

If you already have permissions assigned to user roles, you do not need to do anything else to enable the security on business entities. After you upgrade, Data Director automatically reflects the results of the user role permissions.

User Roles and REST APIs

The APIs are enhanced to support MDM Hub user roles. In all cases, a user must have permission to read a record before the other permissions are processed. The user role permissions are inherited by the business entity, and then the field filters can be used to restrict access to records based on the value in a field.

The following REST APIs return the user role privileges in the <operations> element for objects and relationships:

- GetMetadata
- ListMetadata

Data Filters with User Roles

You can create data filters on fields in a business entity and assign user roles to those filters. Based on the value in the field within a record, the user might or might not be able to see the entire record. You can also

create filters on nodes to determine whether a user should have access to the parent record when the node is empty.

Note: This feature is similar to data security filters for subject areas, however data filters for business entities are case insensitive.

Tasks with User Roles

User role privileges apply to the workflow tasks that you create for business entities. A user can take an action on tasks for which they have role privileges. For example, a user can take action on a merge task only if their user role includes the merge privilege.

Default Values for Business Entities

You can add default values to fields. In Data Director, a single default value appears in the field. A list of default values appears as a drop-down list.

User Interface Enhancements for Security

When an MDM administrator creates user role privileges, the privileges affect the Data Director user interface. For example, if a user does not have access to a business entity, that user cannot see the business entity or its records.

The following table summarizes the role privileges for business entities and describes how the privileges affect the behavior of the Data Director user interface:

Business Entity Action	Data Director Behavior
Create records	In the New menu, you can see only the types of business entities for which you have permission to create records.
Read records	You can view the records for the business entities that you have permission to read. Other records are inaccessible.
Update records	In a record view, the Edit button is enabled when you have permission to edit business entity records. Otherwise, the Edit button is not visible.
Delete records	The Delete icon is enabled when you have permission to delete business entity records.
Search for records	When searching for business entities by using smart search, search filters and search results contain only the business entity types that you have permission to view.
Merge and unmerge records	In the Matching Records view, the Merge button and the check boxes at the top of each record are enabled when you have permission to merge and unmerge records. If you add records to the view, the search filters and search results contain records only for the business entities that you have permission to view.

The business entity views inherit the same role privileges as the business entity. For example, if you choose to include a sensitive field in a business entity view, only the users with the role privilege for the record can view or edit it. For information about how user role privileges translate to business entities and business entity views, see the *Multidomain MDM Version 10.3 Provisioning Tool Guide*.

Hub Server Properties Introduced in Version 10.3

You can use the following Hub Server properties to control the run-time behavior of the MDM Hub.

Configure the Hub Server properties in the cmxserver.properties file.

cmx.server.selective.bvt.enabled

By default, a Put or Cleanse Put call applies BVT calculations to all fields in a record instead of updating only the fields specified in the SIF request. To specify that the MDM Hub only applies BVT calculation to fields that are part of the SIF request, set this property to true. Default is false.

cmx.file.allowed_file_extensions

Lists the extensions of files that you can attach to a record or task in the Data Director application. By default, you can attach .pdf and .jpg files. When you specify multiple extensions, separate each value by a comma.

For example, cmx.file.allowed file extensions=pdf, jpg, png, txt, zip, exe.

cmx.file.max_file_size_mb

Specifies the size limit of files that you can attach in the Data Director application.

Note: Data Director applications that use the subject area data model have a static size limit of 20 MB. If you specify a size limit greater than 20 MB, Data Director applications that use the subject area data model uphold the static size limit of 20 MB. Data Director applications that use the business entity data model uphold the size limit defined in the cmx.file.max file size mb property.

cmx.server.attachment.temp.ttl_minutes

Number of minutes after a file is created in the TEMP storage before it expires. Set to 0 to prevent files from expiring. Default is 60.

cmx.ss.engine

Required if you want to use the Elasticsearch engine for search. Manually add the property and set to es.

ex.max.conn.per.host

Sets the maximum number of Elasticsearch nodes that you want to connect to the host. Set to the number of Elasticsearch cluster nodes on the host.

ex.max.threads

Sets the maximum number of threads that you want the Apache asynchronous non-blocking receiver to use for each node in the Elasticsearch cluster. Default is 1.

Change the value only when suggested by Informatica Global Customer Support.

es.index.refresh.interval

Sets the interval, in seconds, for Elasticsearch to commit the changes to the data after an Initially Index Smart Search Data batch job is run. The data is available for search after this time interval. Default is 30.

This property impacts the high indexing volume encountered during initial indexing. Change the value only when suggested by Informatica Global Customer Support.

ssl.keyStore

Required if you use the HTTPS port of the application server to configure the Hub Server. Manually add the property. Absolute path and file name of the keystore file.

ssl.keyStore.password

Required if you use the HTTPS port of the application server to configure the Hub Server. Manually add the property. Plain text password for the keystore file.

ssl.trustStore

Required if you use the HTTPS port of the application server to configure the Hub Server. Manually add the property. Absolute path and file name of the truststore file.

ssl.trustStore.password

Required if you use the HTTPS port of the application server to configure the Hub Server. Manually add the property. Plain text password for the truststore file.

Search with Apache Solr is Deprecated

Effective in version 10.3, the search functionality in Data Director that used Apache Solr is deprecated. Informatica will drop support for search with Solr in a future release. You can use search with Elasticsearch to find records in Data Director. Elasticsearch is an open-source, full-text search engine.

You must configure search with Elasticsearch, which is packaged with the MDM Hub installer. You can set up Elasticsearch as a single node cluster or as a multi-node cluster to provide distributed indexing and search. For a smooth transition, the APIs that were supported for search with Apache Solr are supported for search with Elasticsearch.

Task Inbox

Effective in version 10.3, you can configure the columns and the filters that you want to view in the task inbox. Use the Provisioning Tool to configure the columns and the filters for the task inbox.

Java Virtual Machine Settings for Smart Search

If you want to configure smart search for the MDM Hub, configure the Java Virtual Machine (JVM) by setting the Java options for smart search.

Set the following Java options for smart search:

-Dmdm.ps.zk.node

Required if you want to use smart search with Solr. Set this Java option on the JVM for the Process Server that is intended to be the ZooKeeper server. Set to true.

-Dmdm.ps.search.node

Required if you want to use smart search with Solr. Set this Java option on the JVMs for the Process Servers that will have search processing enabled and function as Solr servers. Set it to true.

-Dsearch.service.port

Required if you want to use smart search with Solr. Required if you want to install multiple Process Servers on the same machine but on different JVMs and enable smart search on all the Process Servers on the machine. This Java option specifies the port used by the JVM for the search service. To avoid port conflicts, use the default port for the JVM of one Process Server, and set this Java option to the relevant port numbers for the JVMs of the remaining Process Servers.

REST API Enhancements

When you use REST APIs to create or update child records, you can add the child records in the same POST request. Previously, you had to make two requests.

When you use REST APIs to add a child record, you can point to a specific parent record. Previously, you could not specify a parent record in the request.

Message Trigger Enhancement

When a cross-reference record is restored, the MDM Hub can trigger a message to be placed in the JMS message queues. To set up message triggers for an event that restores a cross-reference record, use the Schema Manager. In the **Events** section of the **Message Triggers** page, select **Restore**, which is the new event included in the section.

Hub Server Properties

com.informatica.mdm.message.queue.max.bytes.threshold

You can create a maximum limit for messages sent to the message queue. To specify the maximum size in bytes of messages sent to the message queue, set this property. If a message exceeds the specified size, the message is not sent and the message status is set to Failed.

cmx.server.load.nonsmos.sourcesystem.enddate.like.smos

Sets the relationship end-date of a system that is not a State Management Override System (SMOS) to be the same as that of an SMOS.

cmx.server.override_orstitle

When you log in to Informatica Data Director (IDD), the dashboard displays a long title of all the subject areas that have tasks for the current user. To display a preferred default title when you log in to IDD, set the cmx.server.override_orstitle property to a preferred title in the cmxserver.properties file.

For example, if you set the property to All Subject Areas, the title appears as Tasks for All Subject Areas onscreen.

cmx.server.task.grouppotentialmergebyruleid

Specifies that a manual match task that generates multiple matches creates multiple task entries with the same ROWID. You can set the property to false to create one task for each match entry.

cmx.web.console.session.download.timeout

Specifies the amount of time in minutes that you want to allow for launching the Hub Console after user authentication. Default is 5. The Java Network Launch Protocol (JNLP) resources that the Hub Console requires must download within the specified time. If the JNLP resources fail to download within the specified time, users must reauthenticate to download the JNLP resources.

Grouping of Hub Servers and Process Servers

enable Save For Period Dialog For Hm Rel

Enables the effective period dialog box that appears when you update a Hierarchy Manager-enabled record in IDD. Set to false to disable the effective period dialog box.

enableTaskAttachments

Specifies whether users can attach files to tasks when using the legacy views and Informatica BPM (ActiveVOS) Subject Area Workflows with Data Director. Set to true to enable attachments and to show the **File Attachments** section in the **Task Details** dialog box and in the **Create Task** dialog box.

hideSystemColumnsInResult

Specifies whether the system columns appear in the search results. Set to true to hide the system columns in IDD search results.

overrideTextAreaColumnOrder

If you configure a column as a text area in a subject area, the text area column always appears at the bottom of the layout regardless of column order.

Set to false to ensure that text area columns appear in their specified order in a layout. Set to true to ensure that text area columns in a subject area appear at the bottom of the layout regardless of column order.

Save Handler User Exit Enhancement

In Save Handler user exits, you can use the getChangedChildren method to return modified or added child or grandchild records in a specified base object.

The user exit returns all records that were added, deleted, or updated. You can select the type of changes returned by the user exit. For example, the user exit can return a combination of removed and updated children records.

Date Format Enhancement

You can change the default date format used by the calendar in the Entity 360 framework.

To change the default date format, use a text editor to create a bundleE360.properties file that contains the property DATE TIME LONG FORMAT. Then add the bundleE360.properties file to the following location:

<distribution directory>\hub\server\resources\entityE360

Note: If it does not already exist, create the entityE360 directory.

Start Workspace Enhancements

To help you prioritize tasks, the Start workspace has a **Create date** column that displays the date a task was created. The Start workspace also has an **Owner** column that displays the current owner of a task.

Configuration Automation Tools Enhancements

You can delete a single user in the MDM Hub Master Database, and synchronize a single user in the LDAP server with the MDM Hub roles.

You can use the following properties to automate user management:

Property	Description
MDM.new.user.email <n></n>	Email address of the user that you want to create.
LDAP.attribute_name.for.user.email	Synchronizes the email address of a user from the LDAP server to the Operational Reference Store.
LDAP.attribute_name.for.username	Synchronizes attributes other than a common name or a user ID from the LDAP server to the Operational Reference Store.
LDAP.strip_slashes_from_usernames	Removes slashes from user names such as ${\tt Boyd} \setminus$ to make the synchronization process work.
LDAP.cleanup.before.sync	Removes the users that are assigned in an Operational Reference Store before synchronizing users with roles.

User Exit Enhancement

Effective in version 10.2 HotFix 2, you can set effective periods in the Hierarchy Manager user exits.

Previously, you could only set effective periods in the Save Handler user exit.

Hub State Indicator is Not Putable

Effective as of version 10.1 HF2, the system column HUB_STATE_IND cannot be set as putable. The change was not announced in that release.

In the *Informatica MDM Multidomain Edition Version 10.2 HF2 Configuration Guide*, the list of exceptions for the property Putable is updated to include HUB_STATE_IND.

New Features (10.2 HotFix 1)

History View Enhancements

Improved the usability of the History view by adding the following record fields:

Last Update Date

Displays the date the record was most recently updated.

Updated By

Displays the name of the user that updated the record.

Also, the change details in the History view include the first and last names of the user that made the change.

Previously, only the user name that was configured in the Hub Console appeared in the change details. To display more meaningful names in the change details, launch the Hub Console and update the user definitions to include the first and last names.

Restricting Access to Business Entities

In the Provisioning tool, you can configure IDD applications to have business entities that are not visible to all users within the Entity 360 framework. If you want to hide specific business entities for security reasons, clear the **Visible** check box when you configure a business entity in an IDD application.

Previously, all business entities in an IDD application were visible to all users in the Entity 360 framework.

Populating a Foreign Key Column

In the foreign key column for a business entity, you can browse and select a related business entity from a list of related business entities. The selected business entity must be searchable.

Previously, you had to manually enter the ROWID of a business entity in the foreign key column.

Additionally, when you generate a business entity schema, the Provisioning tool generates business entity lookup fields.

Performance Optimization of a SearchQuery Request

A SearchQuery request can return results that contain pending data changes to a base object.

Previously, query results timed out if a base object contained pending changes.

Batch Group Job History

In the Batch Group tool in the Hub Console, you can specify the number of days of history to process for a batch group job log. By default, logs for batch jobs consider all history, but you can reduce the number of days considered.

To specify the number of days of history to process for a batch group job log, set the cmx.server.jobControl.noOfDays property in the cmxserver.properties file.

Disabling Message Queue Polling

In a multinode environment, you can disable message queue polling for individual nodes. To disable message queue polling, set the mq.data.change.monitor.thread.start property to false in the cmxserver.properties and cmxcleanse.properties files.

You can confirm the operation of message queue polling while in DEBUG mode.

- On nodes where the value of mq.data.change.monitor.thread.start is false, the message Monitoring is disabled appears in the logs.
- On nodes where the value of mq.data.change.monitor.thread.start is true, the message Data changes monitoring started appears in the logs.

By default, message queue polling is enabled on all Java virtual machines where an MDM Hub EAR file is deployed. When you use multiple poller threads for data change monitoring and for publishing messages, the messages might not publish in the correct sequence. To control the sequence in which the messages are published, use a single poller thread.

Global Properties

You can use the following global properties to control the run-time behavior of the Informatica Data Director application:

bulkexportloadsize

Sets the maximum number of records to load for each thread when you export data to a Microsoft Excel file.

exportusingmultithread

Enables multithreading for data export to a Microsoft Excel file.

CompositePagerTotalRecords

Maximum number of ActiveVOS tasks that Informatica Data Director sorts. By default, Informatica Data Director sorts ActiveVOS tasks that are not case sensitive. If there are more than the value of CompositePagerTotalRecords to sort, case-sensitive sorting is database dependent. If the database is Microsoft SQL Server, the sorting is not case sensitive. If the database is Oracle or IBM DB2, the sorting is case sensitive.

convert2DigitYearTo4Digit

Enables the adjustment of a two-digit year entry to a four-digit year entry.

enableCreateBEMenuGrouping

Specifies whether you can define logical groups based on subject areas for the **Create** menu for business entities. The property is required if you have a large number of subject areas.

expandDropDownListShowFullValue

Enables expansion of the drop-down list in the Search tab for lookup records.

qrytaskidfromprocessidtotalretry

Number of attempts that Informatica Data Director makes to reload an ActiveVOS task.

qrytaskidfromprocessidwaitintrvlmillis

Number of milliseconds that Informatica Data Director waits before attempting to reload an ActiveVOS task.

proactiveMatchResultSort

Configures the sort order in which the potential matches appear in the Informatica Data Director application.

MDM Support Tools

The MDM Support tools are a collection of tools in the Hub Console. Use the tools to gather configuration information, track user configurations, replicate issues, run system health checks, and simulate matches.

The MDM Support tools contain the following tools: Configuration Support Manager (CSM) Tool

The Configuration Support Manager (CSM) tool enables you to generate a CSM report. The report gathers configuration information from the Hub Server, Process server, and database server, which helps to troubleshoot issues.

User Migration Tool

The User Migration tool enables you to create or update multiple MDM Hub user accounts. You can also migrate user accounts and user-to-role assignments from one MDM Hub environment to another.

Match Analysis Tool

The Match Analysis tool assesses issues related to tokenization in the MDM Hub. The tool also provides a health check for the MDM Hub environment.

Match Simulator Tool

The Match Simulator tool tests undermatching and overmatching scenarios in the MDM Hub. The tool reduces the manual effort involved in troubleshooting matching issues.

Performance Optimization of a Batch Unmerge Job

During an Unmerge batch job, the MDM Hub optimizes performance of the batch job by limiting BVT calculation of child foreign key records.

Previously, unmerge batch jobs of base objects with a large volume of cross-reference records and multiple child records could fail with an out of memory error message.

Option to Export a Single Record from Search Results

You can set up privileges for roles to only allow the export of a single record from the Informatica Data Director Search Results page.

Restricting low-level users to export only one record at a time prevents the inadvertent export of entire data sets. To restrict privileges to single record export, use the Roles tool in the Security Access Manager in the Hub Console. Enable the privilege EXPORT_PROFILE/ExecuteSingleRow for a selected role.

Previously, you could set privileges for roles to either allow export of selected rows or all rows.

Promotes a pending merge task based on the task data from the BPM workflow. Use to find all pending merge tasks for a specific interaction ID.

Informatica MDM Multidomain Edition supports Informatica AddressDoctor version 5.10.

Internet Protocol Version 6

Informatica MDM Multidomain Edition supports Internet Protocol version 6 (IPv6).

Changes (10.2 HotFix 1)

Proxy Role

Effective in version 10.2 HotFix 1, the Operational Reference Store that you create contains a proxy role.

Previously, the proxy role had been deprecated. Due to demand, the proxy role has been reinstated.

Jaspersoft Removed from the Resource Kit

Effective in version 10.2 HotFix 1, Jaspersoft is not included in the MDM Multidomain Edition Resource Kit.

Customers wishing to integrate dashboards into Informatica Data Director are recommended to rather use their corporate business intelligence tool of choice, or to use Highcharts or other charting tools. Any report that can be embedded in an iFrame can be embedded in a start page or Entity360 page in Informatica Data Director.

Allow Null Update Property

Effective in version 10.2 HotFix 1, all processes that calculate the best version of the truth treat null values the same way. Previously, some processes ignored the **Allow Null Update** property in the staging table and used the **Apply Null Values** property in the base object table.

When a source system contributes a null value for a column, a process refers to the setting of the **Allow Null Update** property for that column in the staging table.

- If the Allow Null Update property is enabled on the column, the process can write the null value to the base object record.
- If the **Allow Null Update** property is disabled on the column, the process downgrades the trust for the null value.

• If a process cannot resolve the setting of the **Allow Null Update** property in a staging table, the process uses the setting for the **Apply Null Values** property in the base object table.

BeMDMWorkflow ActiveVOS Project

If you upgrade from an earlier version, redeploy the BeMDMWorkflow project after you upgrade. If you have customized the workflows, use ActiveVOS Designer to add the following code within the TaskFilter complex type in the cs.wsdl file:

If an obsolete property remains in the properties file after you upgrade, the property is ignored. You can safely remove the property from the file.

New Features (10.2)

Hub Server Properties for Informatica Data Director

You can add the following property to the cmxserver.properties file to configure Informatica Data Director:

cmx.e360.match_xref.view.enabled

Determines if the Entity 360 framework Matching Records view and Cross-reference view appear. If true, the Entity 360 framework view appears. If false, the legacy views appear. During installation, the default is true. During upgrade of existing software, the default is false.

Note: The Entity 360 framework Cross-reference view supports tree unmerge. For linear unmerge support, continue to use the legacy Cross-reference view.

Password Hashing

The MDM Hub uses a password hashing method to protect user passwords. The MDM Hub master database stores the user passwords in hashed form. When users log in to the MDM Hub, their request is encrypted with a combination of public and private keys. To authenticate users, the MDM Hub decrypts their request, generates the hash, and compares the value with the hashed value retrieved from the master database.

The hashing algorithm is a concatenation of the password string and multiple randomly generated values. The default algorithm used for password hashing is SHA3. However, you can also configure a custom hashing algorithm. You configure the hashing implementation class during installation of the MDM Hub. Alternatively, you can configure the hashing implementation class through the Hub Server properties in the cmxserver.properties file.

Password hashing replaces Blowfish encryption in the MDM Hub.

Security Configuration Utility

The security configuration utility helps you to manage some of the security settings in an MDM Hub implementation. With the utility, you can reset the passwords of MDM Hub users, change the hashing algorithm used in the MDM Hub, and change the certificate provider. You can also use the security configuration utility to update the customer hashing key that is used to create the hashing algorithm.

Provisioning Tool Enhancement

The user interface of the Provisioning tool is enhanced to facilitate ease of use. The user interface includes simple user input fields that replace complex XML configurations.

Layout Designer

DaaS Provider Component

Use the DaaS Provider component to search an external data service for information about a business entity. You require an existing relationship with the third-party data as a service provider.

You can enrich and augment your business entity data with the data from third-party data providers. You can integrate the MDM Hub with Data as a Service (DaaS) providers to access data that is reliable, accurate, and complete.

Use the Provisioning tool to configure the integration with the DaaS providers. You can specify the business entity fields that you want to populate with the data from the DaaS providers.

In the Informatica Data Director, use the DaaS Providers component to request a DaaS provider for data. You can search for records, compare the results, and select the entities that you want to convert and merge into a business entity record.

Many-to-Many Relationships

Cross-reference Records View

Use the Cross-reference Records view to establish the best version of the truth for business entities. The view is built on the Entity 360 framework.

Data stewards can use the Cross-reference Records view to examine the lineage of the full business entity, including all child entities, and can now unmerge child records. Data stewards can then make adjustments to ensure the master record genuinely represents the best version of the truth.

If you install MDM Multidomain Edition version 10.2, the view is enabled by default. If you upgrade from a previous version, set the cmx.e360.match_xref.view.enabled property in the cmxserver.properties file to true to enable the view. The view supports tree unmerge. For linear unmerge support, continue to use the IDD XREF view. During installation, the default is set to true. During upgrade of existing software, the default is set to false.

History View

Use the History view to review changes to the data in chronological order. The view is built on the Entity 360 framework.

The History view displays a chronology of data changes over the lifespan of the business entity. You can view the data that existed in the business entity at any point in time in the chronology. View the data before a data event and after a data event to determine if the event caused an inappropriate data change. A data event is any action that changes the data in a business entity, such as an edit or a merge operation.

Matching Records View

Use the Matching Records view to identify and resolve duplicate records. The view is built on the Entity 360 framework.

By default, the Matching Records view contains the target business entity plus any business entities that satisfied a match rule. You can also search for business entities that did not satisfy a match rule, and add those entities to the view.

Compare the root records of the similar business entities and select the ones that you think are duplicates. Then compare the child records and descendant records in the business entities. If you find duplicate sibling records at any level, you can select the records to include in the merge process. Before you start the merge process, you can preview the merged business entity. **Note:** If you need to override a value, edit the business entity in the Cross-reference Records view. Overrides are not available from the Matching Records view.

If you install MDM Multidomain Edition version 10.2, the view is enabled by default. If you upgrade from a previous version, set the cmx.e360.match_xref.view.enabled property in the cmxserver.properties file to true to enable the view.

Merge Cascade for Descendant Records

When you use business entity model, the merge process runs a merge cascade on the child and descendant records.

- At the root level, the merge process merges the data in the root records of the business entities.
- At a child level, when the parent-to-child relationship is a one-to-one relationship, the merge process merges the sibling child records. After the merge process handles a child record, it tries to merge each level of descendant records using the same merge strategy.
- At any level, when the parent-to-child relationship is a one-to-many relationship, you can select sibling records to merge in the **Matching Records** view.

The merged business entity contains the merged root record, the merged sibling records, and all the child records and descendant records that were not merged.

Timeline View

You can use the Timeline view to view changes to data over a period of time. The Timeline view is available only to customers who upgraded from the subject area model to the business entity model.

In IBM DB2 environments, before you upgrade, add the ActiveVOS database connection properties to the build.properties file in <MDM Hub installation directory>/hub/server/bin.

execution logic. To use external callouts, you must build the bes-external-call.ear file and deploy it on the application server.

The BESExternalCall folder contains a sample custom-logic-service.wsdl file with the XML Schema Definition (XSD) for the external callouts. Specifying Primary Key Columns for Hard Delete Detection

When you create a unique primary key by concatenating values from multiple source columns, the hard delete detection (HDD) process looks at the inputs to the function and monitors all the input source columns. You can now override this behavior by listing the columns to monitor in the hard delete detection repository table.

For example, you create a custom function with many inputs. Within the custom function, some of the source columns are inputs to a concatenate function that creates the unique primary key. Other source columns pass through the custom function unchanged. The HDD process cannot see what happens within a custom function. Therefore, the HDD process monitors all the inputs to the custom function. You want the HDD process to monitor only the source columns that contribute to the primary key.

To focus the HDD process on the subset of source columns that contribute to the primary key, configure the C_REPOS_EXT_HARD_DEL_DETECT repository table. Add an HDD_LANDING_PKEY_COLUMNS column, and insert a comma-separated list of the column names.

Previously, to see the New drop-down menu in IDD, you only had to assign read privileges on the subject area of the associated base object.

Fill on Gap

Effective in version 10.1 HotFix 1, for timeline-enabled base objects, you can enable the **Fill on gap** property in the Hub Console. You set the property for the base object in the associated staging table. Previously, you could only enable the **Fill on gap** property through the C_REPOS_TABLE for the associated staging table.

Preserving Source System Keys

Effective in version 10.1 HotFix 1, when the option to preserve source system keys is enabled, source system keys are preserved for initial data loads and for all subsequent data loads.

Previously, when the option to preserve source system keys was enabled, source system keys were preserved for initial data loads only.

Removed INFA_MDM.zip File

Effective in version 10.1 HotFix 1, the obsolete file INFA_MDM.zip was removed. The MDMWorkflow.zip file contains the current ActiveVOS workflows.

Task Manager Enhancement

Effective in version 10.1 HotFix 1, in the Task Manager, the task inbox spans the width of the browser window so that the column data is easier to read. When you review a task, the review panel opens below the task inbox. Previously, the panels were displayed side-by-side.

Merge Task Enhancement

Effective in version 10.1 HotFix 1, after you merge records from the Merge Preview, you see confirmation of the merge. Previously, a blank page was displayed.

Matches View Enhancement

Effective in version 10.1 HotFix 1, in the Matches View, you can highlight the rows with matched attributes by selecting the **Show Matched Rows** check box. Previously, the rows were not highlighted.

Business Entity Schema

Effective in version 10.1 HotFix 1, the business entity schema is updated to support pagination for sorted search results. You must regenerate the business entity schema after you upgrade.

New Features (10.1)

Provisioning Tool

The Provisioning tool is a tool to create business entity models and configure the Entity 360 framework. To create a business entity model, you create a root node and then establish relationships between nodes. These relationships are based on foreign key constraints that you define using the Hub Console. After you build the business entity model and configure the nodes you can publish the configuration to the MDM Hub.

Technical specialists can use the Provisioning tool to perform the following tasks:

- Use the graphic user interface to configure the business entity model. An XML editor is provided so you can configure the XML files directly for all configurations related to business entities.
- Use the graphic user interface to configure the properties for each node. For example, you can configure search properties and display names.
- Publish XML configuration files to the MDM Hub. The Repository Manager validates the configuration and reports any errors. You do not need to upload BLOB files to a repository table manually.

Informatica MDM Multidomain Edition technical specialists can use the Provisioning tool to perform the following activities:

- Create a business entity model. For implementation with custom user interfaces only. You cannot create a
 business entity model if you implement business entities in Informatica Data Director (IDD).
- Create a reference entity. For implementation with custom user interfaces only. You cannot create a
 reference entity if you implement business entities in Informatica Data Director.
- Configure the business entity nodes.
- · Configure the search properties for each node in the business entity model.
- Generate the XML files for the following configurations:
 - REST services

- Write business entity service
- Search
- Configure the XML files for Entity 360 framework configuration.
- Configure the XML files for BPM tasks.
- Configure the XML files for business entity view and the transformation service.
- Publish the configuration files to the MDM Hub.

Differences Between Versions of Informatica Data Director

In previous versions of Informatica Data Director (IDD), data was organized around subject areas and aggregated into subject area groups. IDD used the subject area definition to determine how to treat each foreign key relationship in an Operational Reference Store (ORS).

In the latest version of IDD, data is organized around business entities. A business entity can be anything that has significance to an organization. For example, your organization might define a business entity type of Person. The customer John Smith is a business entity of type Person. In the MDM Hub Store, a business entity corresponds to a record in a base object table.

The following table describes some of the differences between the versions of IDD, depending on whether you use subject areas or you use business entities.

IDD with Subject Areas	IDD with Business Entities
Subject area depth is limited to three levels	Business entity depth is unlimited
n/a	Entity 360 framework
Custom workspaces through IDD configuration file	Custom Start workspaces available in Entity 360 framework

Import Master Data	Import Master Data is not available in version 10.1.0

Business Entity Views and Transformations

You can use the business entity views to expose the data in a business entity to your users in multiple ways and in formats suitable for the users. Business entity views provide a separation of low-level business entity and user interface related views. You can transform a business entity to a business entity view and a business entity view back to a business entity.

You can use the business entity views XML to define the business entity views and the transformation configuration XML to define the transformation of a business entity to a business entity view and back. You can use the Provisioning tool to manually define the business entity views and the transformation configuration XML.

REST API Business Entity Service Calls

You can operate on multiple child branches at various depths in a single REST API business entity service request.

Hub Server Properties for the Tokenization and Match Process

cmx.server.strp_clean.execution_mode

Configures the scope of operation of the background cleanup process on the match key table.

cmx.server.strp_clean.ors

Specifies the names of the Operational Reference Stores on which the background cleanup process must run to delete match tokens that are not valid.

cmx.server.strp_clean.strp

Specifies the Operational Reference Store and base object combinations for which the background cleanup process must run to clean up match key tables.

cmx.server.strp_clean.delete_records_count

Specifies the number of records to clean up from the match key table.

cmx.server.strp_clean.retry_sec

Specifies the time duration in seconds for which you want the MDM Hub to search for records with match tokens that are not valid in the match key table.

cmx.server.strp_clean.threads_count

Specifies the number of threads that the MDM Hub uses when it searches for records with match tokens that are not valid in the match key table.

Configures the number of threads that the MDM Hub uses to update records in the match key tables.

cmx.server.stripDML.useUpdate

Specifies whether or not the match tokens must be marked as not valid instead of deleting them.

Informatica Data Director New Features

Hide the Data Workspace in Informatica Data Director

When you enable the Entity 360 framework for Informatica Data Director (IDD) applications, IDD users edit and manage master data from an entity workspace instead of from the Data workspace. You can reduce confusion for IDD users by hiding the Data workspace and the related user interface elements for all IDD applications. You hide the workspace by setting the cmx.dataview.enabled in the cmxserver.properties file.

In a new installation, the Data workspace is hidden by default. When upgrading, if the cmx.dataview.enabled property was not specified, the Data workspace is shown. If this property was specified, the IDD applications continue to respect the pre-upgrade setting. For more information, see "Hub Server Properties" in the *Multidomain MDM Configuration Guide*.

Wildcard Search

You can use the asterisk wildcard character (*) with the search string to perform a wildcard search. Use the wildcard character at the end of the search string or in between the search string. For example, if you want to search for John, you can specify Jo* or J*n.

Search String Suggestions

You can configure smart search to suggest search strings based on the strings that you type. You can select one of the suggested values as the search string.

Jaspersoft Report in Start Workspace

If you use the business intelligence tool Jaspersoft to develop and analyze reports, you can display the reports in the Entity 360 framework for IDD. You can configure the Start workspace to display Jaspersoft reports.

Upgrade with Zero Downtime

When you need to upgrade Informatica MDM software but stakeholders require uninterrupted access to master data in the MDM Hub Store, you can use the zero downtime feature. While the primary Hub Store is offline for software updates, a secondary duplicate Hub Store stores changed data and responds to requests for master data.

Note: Informatica MDM uses Oracle GoldenGate for database replication.

Zero downtime is supported for Hub Stores that reside within IBM DB2 databases or within Oracle databases.

If you do not run the migration script, the tasks do not appear in the Task Manager. Regularly run the migration script until all the tasks that were created before you upgraded to version 10.1 are processed.

Tokenization Process

Form View for the Sections in the Entity View

To specify that the MDM Hub always tokenizes updated records in these scenarios, set this property to true. Default is false.

cmx.server.selective.bvt.enabled

By default, a Put or Cleanse Put call applies BVT calculations to all fields in a record instead of updating only the fields specified in the SIF request. To specify that the MDM Hub only applies BVT calculation to fields that are part of the SIF request, set this property to true. Default is false.

com.informatica.mdm.message.queue.max.bytes.threshold

You can create a maximum limit for messages sent to the message queue. To specify the maximum size in bytes of messages sent to the message queue, set this property. If a message exceeds the specified size, the message will not be sent and the message status set to Failed.

Enables the effective period dialog box that appears when you update a Hierarchy Manager-enabled record in IDD. Set to false to disable the effective period dialog box.

hideSystemColumnsInResult

Specifies whether the system columns appear in the search results. Set to true to hide the system columns in IDD search results.

In the Batch Group tool in the Hub Console, you can specify the number of days of history to process for a batch group job log. By default, logs for batch jobs consider all history, but you can reduce the number of days considered.

To specify the number of days of history to process for a batch group job log, set the cmx.server.jobControl.noOfDays property in the cmxserver.properties file.

Maximum number of ActiveVOS tasks that Informatica Data Director sorts case-insensitively. By default, Informatica Data Director sorts ActiveVOS tasks case insensitively. If there are more than the value of CompositePagerTotalRecords to sort, case-sensitive sorting is database dependent. If the database is Microsoft SQL Server, the sorting is case insensitive. If the database is Oracle or IBM DB2, the sorting is case sensitive.

convert2DigitYearTo4Digit

Enables the adjustment of a two-digit year entry to a four-digit year entry.

expandDropDownListShowFullValue

Enables expansion of the drop-down list in the Search tab for lookup records.

qrytaskidfromprocessidtotalretry

Number of attempts that Informatica Data Director makes to reload an ActiveVOS task.

qrytaskidfromprocessidwaitintrvlmillis

Number of milliseconds that Informatica Data Director waits before attempting to reload an ActiveVOS task.

proactiveMatchResultSort

Configures the sort order in which the potential matches appear in the Informatica Data Director application.

History View Enhancements

Specifying Primary Key Columns for Hard Delete Detection

When you create a unique primary key by concatenating values from multiple source columns, the hard delete detection (HDD) process looks at the inputs to the function and monitors all the input source columns. You can now override this behavior by listing the columns to monitor in the hard delete detection repository table.

For example, you create a custom function with many inputs. Within the custom function, some of the source columns are inputs to a concatenate function that creates the unique primary key. Other source columns pass through the custom function unchanged. The HDD process cannot see what happens within a custom function. Therefore, the HDD process monitors all the inputs to the custom function. You want the HDD process to monitor only the source columns that contribute to the primary key.

To focus the HDD process on the subset of source columns that contribute to the primary key, configure the C_REPOS_EXT_HARD_DEL_DETECT repository table. Add an HDD_LANDING_PKEY_COLUMNS column, and insert a comma-separated list of the column names.

Specifies the number of records to clean up from the match key table.

cmx.server.strp_clean.retry_sec

Specifies the time duration in seconds for which you want the MDM Hub to search for records with match tokens that are not valid in the match key table.

cmx.server.strp_clean.threads_count

Specifies the number of threads that the MDM Hub uses when it searches for records with match tokens that are not valid in the match key table.

Provisioning Tool

The Provisioning tool is a tool to create business entity models and configure the Entity 360 framework. To create a business entity model, you create a root node and then establish relationships between nodes. These relationships are based on foreign key constraints that you define using the Hub Console. After you build the business entity model and configure the nodes you can publish the configuration to the MDM Hub.

Technical specialists can use the Provisioning tool to perform the following tasks:

- Use the graphic user interface to configure the business entity model. An XML editor is provided so you can configure the XML files directly for all configurations related to business entities.
- Use the graphic user interface to configure the properties for each node. For example, you can configure search properties and display names.
- Publish XML configuration files to the MDM Hub. The Repository Manager validates the configuration and reports any errors. You do not need to upload BLOB files to a repository table manually.

Informatica MDM Multidomain Edition technical specialists can use the Provisioning tool to perform the following activities:

- Create a business entity model. For implementation with custom user interfaces only. You cannot create a
 business entity model if you implement business entities in Informatica Data Director (IDD).
- Create a reference entity. For implementation with custom user interfaces only. You cannot create a reference entity if you implement business entities in Informatica Data Director.
- Configure the business entity nodes.
- Configure the search properties for each node in the business entity model.
- · Generate the XML files for the following configurations:
 - REST services

- Write business entity service
- Search
- Configure the XML files for Entity 360 framework configuration.
- Configure the XML files for BPM tasks.
- Configure the XML files for business entity view and the transformation service.
- Publish the configuration files to the MDM Hub.

Informatica Data Director

This section describes new features and enhancements to Informatica Data Director.

Differences Between Versions of Informatica Data Director

In previous versions of Informatica Data Director (IDD), data was organized around subject areas and aggregated into subject area groups. IDD used the subject area definition to determine how to treat each foreign key relationship in an Operational Reference Store (ORS).

In the latest version of IDD, data is organized around business entities. A business entity can be anything that has significance to an organization. For example, your organization might define a business entity type of Person. The customer John Smith is a business entity of type Person. In the MDM Hub Store, a business entity corresponds to a record in a base object table.

The following table describes some of the differences between the versions of IDD, depending on whether you use subject areas or you use business entities.

IDD with Subject Areas	IDD with Business Entities
Subject area depth is limited to three levels	Business entity depth is unlimited
n/a	Entity 360 framework
Custom workspaces through IDD configuration file	Custom Start workspaces available in Entity 360 framework
Static lookups are supported	Lookups supported through reference entities
User exits are supported	Server-side cleansing and validation
Import Master Data	Import Master Data is not available in version 10.0.0 HotFix 3

Business Entity Views and Transformations

You can use the business entity views to expose the data in a business entity to your users in multiple ways and in formats suitable for the users. Business entity views provide a separation of low-level business entity and user interface related views. You can transform a business entity to a business entity view and a business entity view back to a business entity.

You can use the business entity views XML to define the business entity views and the transformation configuration XML to define the transformation of a business entity to a business entity view and back. You can use the Provisioning tool to manually define the business entity views and the transformation configuration XML.

Enables multithreading for data export to a Microsoft Excel file.

enableCreateBEMenuGrouping

Specifies whether you can define logical groups based on subject areas for the Create menu for business entities. The property is required if you have a large number of subject areas.

showShadowColumns

Specifies whether to show shadow columns in the Cross-reference View.

User Authentication and Password Encryption

You can configure authentication for URLs in Informatica Data Director. You can specify the number of columns that you want to show in the table view for child records and grandchild records.

By default, the table view contains up to 20 columns plus 5 hidden columns. You can change the global default value by setting the tableMaxColumns parameter in the C_REPOS_DS_PREF_DETAIL.

Hide the Data Workspace in Informatica Data Director

When you enable the Entity 360 framework for Informatica Data Director (IDD) applications, IDD users edit and manage master data from an entity workspace instead of from the Data workspace. You can reduce confusion for IDD users by hiding the Data workspace and the related user interface elements for all IDD applications. You hide the workspace by setting the cmx.dataview.enabled in the cmxserver.properties file.

In a new installation, the Data workspace is hidden by default. When upgrading, if the cmx.dataview.enabled property was not specified, the Data workspace is shown. If this property was specified, the IDD applications continue to respect the pre-upgrade setting.

Wildcard Search

You can configure smart search to suggest search strings based on the strings that you type. You can select one of the suggested values as the search string.

Allow Null Update Property

Effective in version 10.0.0 HotFix 3, all processes that calculate the best version of the truth treat null values the same way. Previously, some processes ignored the **Allow Null Update** property in the staging table and used the **Apply Null Values** property in the base object table.

When a source system contributes a null value for a column, a process refers to the setting of the **Allow Null Update** property for that column in the staging table.

 If the Allow Null Update property is enabled on the column, the process can write the null value to the base object record.

- If the **Allow Null Update** property is disabled on the column, the process downgrades the trust for the null value.
- If a process cannot resolve the setting of the **Allow Null Update** property in a staging table, the process uses the setting for the **Apply Null Values** property in the base object table.

You set the property for the base object in the associated staging table. Previously, you could only enable the **Fill on gap** property through the C_REPOS_TABLE for the associated staging table.

Preserving Source System Keys

Effective in version 10.0.0 HotFix 3, when the option to preserve source system keys is enabled, source system keys are preserved for initial data loads and for all subsequent data loads.

Previously, when the option to preserve source system keys was enabled, source system keys were preserved for initial data loads only.

Removed INFA_MDM.zip File

Effective in version 10.0.0 HotFix 3, the obsolete file INFA_MDM.zip was removed. The MDMWorkflow.zip file contains the current ActiveVOS workflows.

Task Manager Enhancement

Effective in version 10.0.0 HotFix 3, in the Task Manager, the task inbox spans the width of the browser window so that the column data is easier to read. When you review a task, the review panel opens below the task inbox. Previously, the panels were displayed side-by-side.

Merge Task Enhancement

Effective in version 10.0.0 HotFix 3, after you merge records from the Merge Preview, you see confirmation of the merge. Previously, a blank page was displayed.

Matches View Enhancement

Effective in version 10.0.0 HotFix 3, in the Matches View, you can highlight the rows with matched attributes by selecting the **Show Matched Rows** check box. Previously, the rows were not highlighted.

Business Entity Schema

Effective in version 10.0.0 HotFix 3, the business entity schema is updated to support pagination for sorted search results. You must regenerate the business entity schema after you upgrade.

Secured Connection Between a Process Server and the Hub Server

Effective in version 10.0.0 HotFix 3, when you configure a Process Server in the Hub Console, you can set a property to enable a secured connection with the Hub Server. In the Add/Edit Process Server dialog box, select **Enable Secured Connection (HTTPS)** to enable the secured connection.

In previous releases, you configured a secured connection by setting the Is Secured field to 1 in the C_REPOS_CLEANSE_MATCH_SERVER table.

Tokenization Process

Effective in version 10.0.0 HotFix 3, the MDM Hub generates or updates match tokens when base object records are marked dirty.

The base object records are marked dirty if all of the following conditions are met:

- An update affects match columns in a base object.
- The best version of the truth (BVT) of a match column after the update is different from the old value.

Previously, base object records were marked dirty whenever there was any update to a base object record.

Searchable Field Properties

Effective in version 10.0.0 HotFix 3, you can use the Provisioning tool to configure the searchable field properties.

Previously, you used a change list or manually updated the C_REPOS_CO_CS_CONFIG repository database table.

Multiple Match Indexes

The multiple match indexes feature, which was introduced in a HotFix for version 9.7.1, is not supported in version 10.0.0 or later.

Validation of Changes to the Schema

Effective in version 10.0.0 HotFix 3, if you make any changes to the schema in the Hub Console, such as adding a column to a base object, metadata validation generates a warning. Each change that you make to the schema causes dummy metadata validation and adds an entry to the C_REPOS_MET_VALID_RESULT table.

Batch Jobs

The MDM Hub batch jobs can run in parallel on all the child base objects that are in the match path of the parent base object.

Representational State Transfer Composite Service Calls

You can make Representational State Transfer (REST) composite service calls to perform Hub related operations and manage tasks.

Use the REST APIs to perform the following operations:

- Retrieve the metadata, content metadata, and lookup data of composite objects.
- Merge and unmerge records.
- Retrieve related and matched records.
- Update and delete matched records.
- Create, update, and search for tasks and perform tasks.

Simple Object Access Protocol Composite Service Calls

You can use Simple Object Access Protocol (SOAP) APIs to access all composite services as web services. You can make SOAP calls to create, update, delete, and search for records in a composite object. You can retrieve the metadata, content metadata, and lookup data of composite objects. You can perform operations, such as merge, unmerge, and match records. You can also make SOAP calls to create, update, and search for tasks and perform tasks.

Task Manager

Use the Task Manager to organize, claim, review, and resolve tasks. In the task inbox, review your tasks and all unclaimed tasks. Click a task to open the associated business entity in a review panel to the right of the task inbox. In the review panel, review pending changes and take action on the review task. The Task Manager replaces the Tasks workspace that was present in previous versions.

Task Inbox

The new task inbox is a composite object component that can be added to or removed from an Entity 360 page. By default, the task inbox appears in the Start workspace and in the Task Manager. The task inbox supports tasks that arrive through the BE-AVOS adapter or the SA-AVOS adapter. The BE-AVOS adapter is a new BPM adapter that supports the composite object model. The SA-AVOS adapter is the legacy BPM adapter that supports the subject area model.

Task Inbox Filters

In the task inbox, you can show tasks based on filters. Use the quick filter at the top to switch between My Tasks and Available Tasks. Use the column filters to filter the list by an attribute, such as task type, priority, due date, status, or owner.

Business Entities

You can create and edit business entities in the Entity 360 view.

When you add or edit business entities, the Hub Server validates the data you enter according to the business rules that you configured.


For example, if you enter an address in an incorrect format, the MDM Hub validates the address and replaces it with the address correctly formatted.

You can configure the time that automatic task assignment waits to start after the MDM Hub initializes. If you do not configure a delay, an error can occur when you create tasks.

The following parameter is added to cmxserver.properties:

The value of sip.task.assignment.start.delay is the time in minutes that automatic task assignment waits to start after the MDM Hub initializes. Default is 10 minutes.

ActiveVOS Workflow Adapter based on Composite Objects

You can configure a workflow engine to use the ActiveVOS workflow adapter that is based on composite objects. The ActiveVOS workflow adapter based on composite objects operates using composite services. You must use the ActiveVOS workflow adapter based on composite objects as the primary workflow engine to configure automatic task assignment and direct task assignment. The name of the ActiveVOS workflow adapter based on composite objects is BE ActiveVOS.

Informatica recommends that you use the composite object ActiveVOS workflow engine as the primary workflow engine. Workflow engines based on third-party BPM adapters or the Siperian adapter are deprecated. Informatica will continue to support the deprecated adapters, but they will become obsolete and Informatica will drop support in a future release.

Update the IDD Configuration for the ActiveVOS Adapter based on Subject Areas

- When the data in an existing cross-reference record changes, the record is updated but a new record version is not generated.
- When the effective period of the existing cross-reference record changes, the record is updated but a new
 record version is not generated.
- When a cross-reference record with a new effective period is added for a record, a new record version is generated.

Load Multiple Versions of a Record In a Batch Job

You can load multiple versions of a record from a staging table to the cross-reference table of a base object in one batch job.

To load multiple versions of a record, configure contiguity of effective periods of records in the base object. Also, sequence the versions of a record during the load to the base object, by setting the cmx.server.batch.load.smart_resequencing property to true. You set the cmx.server.batch.load.smart_resequencing property in the cmxserver.properties file.

Decrease the Effective Periods of Record versions in Batch Jobs

Staging Table System Columns

Effective in version 10.0.0 HotFix 1, system columns are added to the staging tables to enhance the MDM Hub capability to track data change events.

The following system columns are added to the staging tables:

PERIOD_REFERENCE_TIME

Specifies a reference date within an effective period to identify a record version that needs to be updated.

TIMELINE_ACTION

Specifies the action to perform on a record version during the load process.

SIF APIs

Effective in version 10.0.0 HotFix 1, elements are added to the Put and cleansePut SIF APIs. The elements specify the timeline actions, reference time for an effective period, and fills gaps between record versions.

Previously, the elements to specify the timeline actions, reference time for an effective period, and to fill gaps between record versions were not available.

Informatica Data Director

This section describes new features and enhancements to Informatica Data Director.

Informatica Data Director User Interface

The Informatica Data Director user interface contains the following new options in the **Action** menu to edit and add record versions:

Edit Data

Use to edit data in an existing record, you cannot change the effective period for the record.

Edit Period Dates

Use to edit the effective period for a record.

Create New Period

Use to add a record version that is applicable for a new effective period.

Smart Search

Smart search uses the SolrCloud feature of Apache Solr to improve the performance of the search requests. SolrCloud uses a cluster of Solr servers to provide distributed indexing and search. The performance results can vary based on your environment and the smart search configuration.

Entity 360 Lookup Links

Informatica MDM Hub

Languages

The following new features related to languages are available:

- When you launch the Hub Console, you can choose to display the elements of the user interface in any supported localized language.
- You can configure the MDM Hub to display all elements of the interface in Spanish and Brazilian Portuguese.

Multiple MDM Hub Master Database

You can configure multiple MDM Hub Master Databases in a single database instance. If you configure more than one MDM Hub Master Database, install an MDM Hub instance for each MDM Hub Master Database.

Informatica Platform Staging

You can integrate the MDM Hub with Informatica platform to run the stage process by using the Data Integration Service.

Informatica ActiveVOS Server

You can install and use the ActiveVOS Server as your workflow engine. Your fulfillment email includes a link to the installer, and the MDM Multidomain Edition package includes a license for the ActiveVOS Server. When you install the ActiveVOS Server as part of the Hub Server installation, the installer performs an embedded installation of ActiveVOS Server. The embedded installation configures an MDM Identity Service for ActiveVOS and deploys predefined MDM workflows and roles to the ActiveVOS Server.

Composite Objects

A composite object consists of a nested structure of base objects. Composite objects are required to view all the information that relates to the root base object in Entity 360 view. Composite objects in the MDM Hub are conceptually the same as subject areas in Informatica Data Director.

Composite Services

You can make composite service calls to create, update, delete, and search for composite object records. You can make Representational State Transfer (REST) composite service calls or Enterprise JavaBean (EJB) composite service calls.

Dynamic Data Masking

Dynamic Data Masking is a data security product that operates between the MDM Hub and a database to prevent unauthorized access to sensitive information. Dynamic Data Masking intercepts requests sent to the database and applies data masking rules to the request to mask the data before it is sent back to the MDM Hub.

Smart Search

You can perform a smart search to find data within a specific collection or all the collections of composite objects based on a search string. The Informatica Data Director application displays the matching fields that can be searched and displayed. The results are ranked based on how closely the results match the search string. You can apply filters to narrow down the results. You can view the details of a result in the Entity 360 view, the data view, and the hierarchy view.

Languages

You can configure Informatica Data Director to display all elements of the interface in Spanish and Brazilian Portuguese.

Entity 360 View

You can use the Entity 360 view to display the records in a composite object. You can see all levels of records in the Entity 360 view. You can configure the layout of the components in the Entity 360 view. You can configure the Entity 360 view to display additional information that relates to the composite object records such as matches and related records. Entity 360 view is disabled by default.

Global Properties

You can use the following global properties to control the run-time behavior of the Informatica Data Director application:

IDD2COCSConverter.prefixCoNames

When the Informatica Data Director configuration is converted to a composite object configuration, determines if a prefixed subject area name is used for the composite object name.

Effective in version 10.0, the application server memory settings for all application servers must be set to the following parameters before installing or upgrading MDM Multidomain Edition. **Note:** Effective in version 10.2, you can omit the following deprecated Java options: -XX:PermSize and -

XX:MaxPermSize.

JBoss and Weblogic

-Xms2048m -Xmx4096m -Xss2000k -XX:PermSize=256m -XX:MaxPermSize=1024m

WebSphere

-Xms2048m -Xmx4096m -Xmso2048m -Xss2000k -XX:PermSize=256m -XX:MaxPermSize=1024m

Previously, the application server memory settings were set to the following parameters:

JBoss

-Xms1024m -Xmx4096m -XX:PermSize=256m -XX:MaxPermSize=1024m

WebLogic

-Xmx4096m -XX:PermSize=256m -XX:MaxPermSize=1024m

WebSphere

-XX:MaxPermSize=512m -XX:PermSize=128m -Xss2000k

Custom MDM Hub Master Database User Name

Effective in version 10.0.0, you can create a custom MDM Hub Master Database user name. The default is cmx_system.

Previously, you could create a custom MDM Hub Master Database user name only in the IBM DB2 environment.

Informatica MDM Hub

Proxy Role

Effective in version 10.0.0, the Operational Reference Store that you create does not contain a proxy role.

If you upgrade to version 10.0.0, the existing proxy roles convert to ordinary roles that you can delete.

Siperian BPM Workflow Engine

Effective in version 10.0.0, the Siperian BPM workflow engine is deprecated. Previously, the Siperian BPM workflow engine was the default workflow engine in the MDM Hub. Informatica recommends that you install the ActiveVOS Server as part of the Hub Server installation. The ActiveVOS Server is the new default workflow engine.

You can continue to use Siperian BPM with this release. Before you upgrade, make a note of the settings defined for the Siperian BPM workflow engine. After you upgrade, define a Siperian BPM workflow engine with the same name and settings that you used in the previous release. Verify that the Operational Reference Stores use the Siperian BPM workflow engine.

If you want to switch workflow engines, first you need to close open tasks. You cannot migrate open tasks from one workflow engine to another.

You have the following options for moving from Siperian BPM to ActiveVOS Server:

- Before you upgrade to this release, close all open tasks. After you upgrade, all upgraded Operational Reference Stores use the ActiveVOS Server as the workflow engine. You need to update your IDD applications to use ActiveVOS Server task definitions.
- If you want to move to ActiveVOS Server after upgrading to this release, you can switch workflow engines
 after the upgrade. When you are ready to switch, close all open tasks. For each Operational Reference
 Store, change the workflow engine from Siperian BPM to the ActiveVOS Server. Update your IDD
 applications to use ActiveVOS Server task definitions.

EJP Protocol for Services Integration Framework Requests

Effective in version 10.0.0, the EJB2 protocol is obsolete and you must use EJB3 protocol to communicate with the MDM Hub through the Services Integration Framework (SIF) requests. If you use the EJB protocol to communicate with the MDM Hub through the Services Integration Framework (SIF) requests, perform the following tasks:

 Replace the existing SiperianClient library classes with the latest version of the SiperianClient library classes.

The siperian-api.jar file located in the following directories contains the SiperianClient library classes:
