Associate Child Records

You can associate child records that part of a root business entity record without having to search the entire records.

Bookmark

You can bookmark various screens on Entity 360.

Export a Business Entity Record

You can now export a business entity record and its related records to a PDF file with the **Download as PDF** menu.

Configure the following in the Hub Server Properties to change the default limitations for business entity download:

pdf_num_of_children

Maximum number of children you can export for each parent business entity. The default value is 1000.

pdf-depth

Maximum depth of child records you can export for a business entity. The default value is 20.

Export Workflow Tasks

Use **Export as Excel** to export the workflow tasks from the Available Tasks or All Assigned Tasks tab of the Task Manager with the required filters.

To change the default limitations for task download, configure the following Hub Server property: cmx.e360.taskdata.export.limit

Number of tasks that you export into an Excel file up to a maximum of 10000 records. Default is 1000.

Selective Filtering

Enable the **filterChildOutput** property in the Search Query Results Options of Entity 360 UI to filter child or grandchild records of a parent business entity. The search displays results based on the filter parameter you specify for the child record.

Configure the following property in the Hub Server Properties to view the **filterChildOutput** property in the Search Query Results Options of Entity 360:

cmx.e360.legacysearch.filterchildoutput

Enable the property to apply filtering on the child or grandchild records for a parent business entity. Default is false.

Managing Record Versions

You can manage data change events of business entities and their relationships through timeline management. A data change event is a change to data that is effective for a time period. When data change events occur, the MDM Hub creates versions of the record instead of overwriting the existing data.

If timeline is enabled, you can create, view, update, and delete versions of a business entity record. You can define the record versions based on their effective periods. Data changes occur over time and are independent of their relationship to other data. The changes to data result in a new version of effectiveness or an updated period of effectiveness for the past, present, or future. You can track these changes to data over a period of time.

Setting the End Date or Time of Record Versions

You can set the end date or time of a record version. The end date or time is between the start date or time of the first version and the end date or time of the last version of a record.

Content Security Policy

Content Security Policy (CSP) is a standard that prevents code injection attacks, such as cross-site scripting. Multidomain MDM has content security policy rules to allow approved origins of content that a browser can load to display website content. The content security policy rules are applied across the system.

When you install Multidomain MDM, default rules are applied that allow only content required for Multidomain MDM to run. You can configure the content security policy to declare approved origins of content that a browser can load to display website content.

Elasticsearch Upgrade

When you upgrade Elasticsearch, in the Provisioning tool, you can specify to add the index details to the upgraded node. The existing node continues to manage search requests until the index details are added to the new node.

Accessibility and Section 508 Compliance

The Multidomain MDM user interface is on the way to being compliant with Section 508 of the Rehabilitation Act. The user interface includes several enhancements to improve accessibility for people with disabilities.

Hub Server Properties

You can use the following Hub Server properties to control the run-time behavior of the MDM Hub.

Configure the Hub Server properties in the cmxserver.properties file.

cmx.login.autocomplete

Optional. Must be added manually. Specifies whether to autofill the user name and password on the login screen. This property works in conjunction with the autofill capability of the browser. To autofill the values, set to true. Default is false. If the browser is set to autofill values and this property is not set or is set to false, the password is not automatically populated. The user can see a list of saved passwords when they move the focus to the password field.

cmx.server.jgroup.name

Optional. Must be added manually if not present. Jgroup name to assign when using Oracle RAC in a multi-node environment. This property must be set to the same value in the cmxserver.properties file on all nodes in the cluster.

Persisting Search Preferences

Effective in verison 10.5, Multidomain MDM automatically saves the search preferences of each user and uses the same preferences when the user performs a search again. The search preferences include the fields that appear in the search results and the sorting order. When a user uses queries, the search preferences are saved for each query. When a user uses the search box, the search preferences are saved for each business entity.

Previously, the search preferences were not automatically saved for each user.

Concurrent Updates in the Provisioning Tool

Effective in version 10.5, multiple users can concurrently perform exclusive configuration tasks in the Provisioning tool, such as adding or editing two different business entities.

Previously, configuration tasks that users concurrently performed weren't saved.

In an environment that uses Red Hat JBoss EAP 7.3, you must set a system property that prevents REST API authentication failures of business entity service requests that do not contain required credentials due to truncated cookie values.

 Open the standalone.conf file: On UNIX. < JBoss installation directory >/bin/standalone.conf

 $On \ Windows. < \ \texttt{JBoss installation directory >} \ \texttt{bin} \ \texttt{standalone.conf.bat}$

 Configure the following option: Dio.undertow.legacy.cookie.ALLOW_HTTP_SEPARATORS_IN_V0

Set to true to set the property as a system property. Default is ${\tt false}.$

Copying a Record in Data Director with Business Entities

You can copy a business entity record, modify it, and then save it as a separate record. When you copy a record, the values from read-only fields are not copied. Read-only field values are populated automatically with default values or remain empty. To copy a record, you need to have permission to create records.

- 1. Search for the record that you want to copy, and then open it.
- 2. From the Actions menu, select Copy. A copy of the record appears.
- Change the values based on your requirements. For example, modify the name, address, or email address.
- 4. Click Save.

Note: When a single layout contains more than one business entity view, and you copy the record, you can save one view only. Click Save, in the view that you want to save.

Editing a Record Containing a Child Record with Pending Changes

You can edit the root record or child records that do not have any pending changes. A yellow pending icon indicates whether a record contains any pending changes.

- 1. From the **Search Results** panel of the **Search** page, open the record that you want to edit. The record opens in a record view.
- 2. Click Edit.

If the button is disabled, you do not have permission to edit the record or the record has changes that are pending approval.

The following image shows the record for Edward John McNair, in edit mode. The record also contains a child record that you cannot edit because it has pending changes.

Deleting a File Attachment

You can delete a file attached to a business record if no workflow triggers are configured for the update event for this business entity.

1. In Data Director, open the record that contains the file you want to delete.

2. Select the file attachment and press Delete.

The following message appears:

The file <fileID>will be permanently deleted from the database after you save the record. Are you sure you want to delete the file when the record is saved? Yes/No

3. Click Yes.

New Facet Label Format Options

You can choose the preferred case for displaying facet values after a search.

- 1. In the Provisioning Tool, select the **Facet** check box.
- 2. From the Facet Label Format drop-down menu, select the preferred option:
 - Lowercase
 - Uppercase
 - Title Case
- 3. Click Save.

Note: You must select an option to be able to save the changes. If you upgrade from a previous version of Multidomain MDM to version 10.4 HotFix 2, you will see the Title Case by default. You can change this in the Provisioning Tool.

Interactive Saving Option in Data Director (E360)

In Data Director (E360), a warning message might appear if you have not entered all the required information when you edit a record.

The following warning appears when you click Save:

Warning(s) Detected. Are you sure you want to save your changes? (Yes/No)

You can ignore this message and proceed to save the record, or you can go back to the record and add the missing information.

You must configure external calls for custom logic and validation of business entity data. The interactive saving option works with any external call, and relies on the following parameter:

ignoreWarnings. Indicates whether the warning-level validation messages are ignored. Set to true to ignore the warning messages. Default is false.

For example, your Data Director can be configured to validate whether every Person record contains a telephone number. When you edit a record, you must enter a telephone number. If you do not enter it, and then click Save, the warning message appears.

Fielded Search Returns Exact Matches from the Child Nodes

Fielded search can return exact matches from within child nodes for a business entity type.

Set the following Java option:

DUseESLegacyFqSearch

This Java option indicates whether a search must return records that contain search values in the same child node, if multiple query fields are at the child level. Set to true to return records that might match the child level query field from different child nodes. Default is false.

Auto-Delete and Auto-Promote Enhancements

Informatica Multidomain MDM now includes the following Auto-Delete and Auto-Promote enhancements:

- Auto-Delete. You can use the Auto-Delete feature in conjunction with the Load Batch method. You cannot call the PUT SIF API to delete a cross-reference record.
- Auto-Promote. A soft-deleted cross-reference record is now automatically reactivated (set to Active status) and you can edit it. The Auto-Promote feature is a part of the Put SIF API.

The following behavior is now enabled:

· When one edit record is associated with one cross-reference record:

• Edit record is auto-deleted when you delete a cross-reference record.

- When one edit record is associated with multiple cross-reference records:
 - Edit record is auto-deleted only when you delete the last remaining Active cross-reference.
- When multiple edit records are associated with multiple cross-reference records:

• All edit records are auto-deleted after you delete the last remaining Active cross-reference record.

- When a Source cross-reference is reactivated or a new Active cross-reference is added:
 - A PUT SIF API Edit call (PUT SIF API without PKEY_SOURCE_OBJECT, but with ROWID_OBJECT), used by Data Director, automatically reactivates the edit record selected by MDM Hub.
- When one edit record is associated with one cross-reference record, unmerge of the cross-reference record includes the edit record as well.

Searching by the Original Rowid Object

You can search for a master record using the original rowid object from any of its cross-reference records.

For example, if 20 records were merged, you can use the original rowid object from any of these records, to search for the master record. In this example, there are 20 original rowid objects. 19 rowid objects are associated with the cross-reference records, and one with the master record.

- 1. At the Query panel, in the search field, type the original rowid object from a cross-reference record.
- 2. Run the search. The search results return the associated master record.

Sample requests

The following sample request queries the Person business entity for records with corresponding original rowid objects. In this example, only one record is returned, based on the value '1' used as a unique identifier ROWID_OBJECT for this Person:

GET http://localhost:8080/cmx/cs/localhost-orcl-DS_UI1/Person? action=query&filter=origRowidObject='1'&outputView=PersonAddressView

The following sample request queries the Person business entity for surviving records with corresponding ROWIDs. In this example, only one record is returned, based on the value '1' used as a unique identifier ROWID_OBJECT for this Person:

Maintaining the Latest Password Information

Informatica Multidomain (MDM) maintains the latest information about the latest password and who changed the password. Password history is not available.

Windows Authentication Support

Effective in version 10.4 HotFix 2, Informatica Multidomain MDM provides Windows Authentication support.

To configure Windows Authentication, open the cmxserver.properties file and set the following property:

cmx.server.database.authentication.method=windowsauthentication

The application will use the Windows Authentication method to connect to the data source.

Note: Windows Authentication is available for JBoss EAP and Oracle WebLogic application servers running on Windows and connecting to a MS SQL server database running on Windows.

External Authentication of MDM Users through Direct Connections

Informatica Multidomain MDM provides support for external authentication of users through direct connections.

Informatica Multidomain MDM can retrieve credentials or connection properties from external vaults/wallets, when it makes direct connections. These connections do not imply direct data source connections as they are managed by the application servers (containers).

Hub Server Properties

You can retain the order of fields from the subject area layout in a business entity, when you generate the business entity schema for the subject area.

Configure the following Hub Server property in the cmxserver.properties file.

Optional. Must be added manually. Set to true to preserve sort order from the original layout. Default is false

Informatica ActiveVOS Version 9.2.4.6 Support

Informatica Multidomain MDM 10.4 HotFix 1 supports only ActiveVOS version 9.2.4.6.

If you upgrade from an earlier version of Multidomain MDM, ensure that you install ActiveVOS version 9.2.4.6.

Reinstated Support for Zero Downtime Upgrade

Effective in version 10.4 HotFix 1, Informatica reinstates support for zero downtime (ZDT) upgrade that was temporarily unavailable in version 10.4.

ZDT upgrade minimizes disruptions when you upgrade Multidomain MDM. For more information, see the *Multidomain MDM Zero Downtime Upgrade Guide* for the database in use.

Zero Down Time Data Replication Delay

Effective in version 10.4 HotFix 1, when you upgrade Multidomain MDM in a zero downtime environment, data replication from the source system to the target system is delayed by 60 seconds.

The delay is applicable only for the first record that is replicated and if the source system and the target system are installed on separate environments.

Support for Adobe Flash Player

Effective in version 10.4 HotFix 1, Informatica Data Director with subject areas does not require Adobe Flash Player.

Support for Adobe Flash Player is deprecated. Adobe announced that it would end support for Flash Player at the end of 2020.

Effective Period View

Effective in version 10.4 HotFix 1, Data Director has a new user interface for the **Effective Period** view and does not require Adobe Flash Player. You can use the **Effective Period** view to investigate data with effective dates.

The **Effective Period** view does not display the timeline for a relationship. The timeline for a relationship appears in the **Network** layout of the **Hierarchy** view.

Dropped Support for Search with Apache Solr

Effective in version 10.4, Informatica dropped support for search with Apache Solr. If you are using search with Apache Solr, you must start using search with Elasticsearch.

For more information about search with Elasticsearch, see the Multidomain MDM Version 10.4 Configuration Guide and the Multidomain MDM Version 10.4 Upgrading From <Version> guide.

Dropped Support for Operating Systems

Effective in version 10.4, Informatica dropped support for the Oracle Solaris and the HP-UX operating systems. If you are using Oracle Solaris or HP-UX, Informatica requires you to use a supported operating system.

For information about supported operating systems, see the Product Availability Matrix on the Informatica Network: https://network.informatica.com/community/informatica-network/product-availability-matrices

Deprecated Support for Adobe Flash Player

Effective in version 10.4, support for Adobe Flash Player is deprecated. Adobe announced that it would end support for Flash Player at the end of 2020.

If you use Data Director with subject areas that requires Adobe Flash Player, Informatica recommends that you migrate to Data Director with business entities.

For information about migrating to Data Director with business entities, see the *Multidomain MDM Version* 10.4 Data Director Migration Guide.

Deprecated Support for Data Director with Subject Areas

Support for Data Director with subject areas is deprecated. Informatica intends to drop support for Data Director with subject areas in a future release.

If you are using Data Director with subject areas, Informatica recommends that you migrate to Data Director with business entities.

If you are a new customer, do not use Data Director with subject areas. You must use Data Director with business entities.

For information about migrating to Data Director with business entities, see the *Multidomain MDM Version* 10.4 Data Director Migration Guide.

Deprecated Support for Informatica Platform Staging

Effective in version 10.4, support for Informatica platform staging that uses the Data Integration Service is deprecated. Informatica intends to drop support for Informatica platform staging in a future release.

You can use Informatica Data Integration and Informatica Data Quality to directly load data into the MDM Hub staging tables. This requires you to manually synchronize changes to the staging tables with the Informatica Data Integration and Informatica Data Quality repositories.

Deprecated Support for Blowfish Encryption

Effective in version 10.4, support for Blowfish encryption is deprecated. Informatica intends to drop support for Blowfish encryption in a future release.

Blowfish encryption is replaced by a secure certificate-based encryption mechanism. The certificates are generated during the installation and upgrade process.

If you are using Blowfish with APIs to decrypt database passwords, Informatica recommends that you update your APIs to use the certificate-based encryption mechanism.

Deferred Support for Zero Downtime Upgrade

Effective in version 10.4, zero downtime (ZDT) upgrade is deferred and is unavailable because of the changes to the mode of authentication for Multidomain MDM.

Informatica intends to reinstate upgrade with ZDT in an upcoming release. If you purchased the ZDT module, we recommend that you wait for ZDT to become available before you upgrade. For more information, contact Informatica Global Customer Support.

Hierarchy Relationships

In the Provisioning tool, you can create hierarchy relationships to define hierarchical relationships between business entities. Then you use the hierarchy relationships defined between business entities to configure hierarchy relationships between records in Data Director.

In Data Director, use the **Hierarchy** view to view, create, and manage hierarchy relationships for a record. You can view the relationships in a hierarchy for an effective date. Or, you can compare the current hierarchy with a version of the hierarchy at an effective date or history date. You can also export the hierarchy.

In the Provisioning tool, you can configure tasks and triggers to ensure changes to hierarchies in Data Director move through an approval workflow. Then in Data Director, when you send your changes for approval, reviewers can compare your changes with the saved hierarchy.

In the Provisioning tool, you can also configure the **Quick View** tab for the **Hierarchy** view. Then in Data Director, you can use the tab to view the details of a record in the hierarchy.


For upgrading customers with relationships in Hierarchy Manager in the Hub Console, use the Provisioning tool to copy the relationships, and then create them as hierarchy relationships or network relationships. Then revert the entity base objects to base objects. After you revert the base objects, you can create new hierarchy relationships or network relationships in the Provisioning tool.

Chart Component

In the Provisioning tool, you can create Chart components. Chart components display a graphical representation of data about business entity records, tasks, or any other types of information you collect about your master data.

When you create Chart components, you configure the appearance of the chart and the type of chart that you want to display. You populate your chart with data collected from default reports or custom reports. You can filter and group the report data used in charts. You can also link data in a chart to a drilldown chart or another interface in Data Director, such as the **Query** tab, **Search** tab, or Task Manager.

When you design custom Home page layouts or additional page layouts, you can add Chart components. When users view your custom Home page or additional pages in Data Director, your charts appear.

The following image shows a sample Home page with Chart components:



You can also interact with default reports and create custom reports by using REST APIs.

Creating Match Rule Sets in the Provisioning Tool

You can use the Provisioning tool to create match rule sets based on a sample data set and the match training.

During the match training process, review a few matched pairs from the sample data set and confirm whether the pairs match. After the review, the match engine creates a match rule set with a confidence score. If the match confidence score is low, retrain the match engine until you get a high match confidence score.

Manage Multiple Tasks

In Data Director, you can perform task administration actions to manage tasks. You can assign, claim, release, or edit multiple tasks. You can also take actions on multiple tasks, such as approve, reject, or disclaim.

The task administration actions that you can perform depend on your role. All users can manage tasks available to their user role. Users assigned the Task Administrator role can manage all tasks. The Task Administrator role is a new role that you can create and assign to users in the MDM Hub, and then enable in the Provisioning tool.

You can use filters or search to find the tasks that you want to manage. For example, you might want to find high priority tasks related to the John Smith record.

The following image shows an example of the Task Manager and the task administration actions that you can perform:

Find and Replace Values Across Multiple Records

In Data Director, you can find and replace multiple values across records. For example, you want to replace all records that do not have the gender identity recorded. You find the records and replace it with the correct gender.

The find and replace operation can trigger a review workflow and create an approval task when the cmx.server.find-replace.task-limit property value is greater than 0. When the number of records being found and replaced exceed the value set for the cmx.server.find-replace.task-limit property, a review and approval task is triggered.

You can also find and replace values across records by using REST APIs.

Import New Records

In Data Director, you can import new data and relationships in bulk from an Excel or a CSV source file. Data Director uses artificial intelligence to identify and map the source file fields to the best target fields. After you import or update data, use the **My Jobs** feature to view and download the import summary report.

You can also import new data and relationships in bulk using REST API's.

Matching New Records with Existing Records

In Data Director, you can compare records that you import with existing records. The match process identifies matched and unmatched records. You can import the unmatched records, delete the records or import all records.

After you import the file, Data Director generates match results that display the matched, unique, skipped, and all records. You can review the results to determine the records you want to import or download.


Triggering Task Review Process

You can configure tasks to trigger a review workflow when users update and import new records. The workflow is reviewed by a user role with privileges, such as, a manager. Use the Provisioning tool to configure a review workflow.

Custom Elasticsearch Index Settings

If the Elasticsearch index settings that Informatica provides does not meet your requirements, use the Provisioning tool to create custom Elasticsearch index settings. You can configure custom analyzers, tokenizers, token filters, and character filters for the Elasticsearch index.

If you upgrade from an earlier version, the filters appear in the same order as they appeared in the existing application configuration. After the upgrade, you can choose to change the display order for the search filters.



Icons and Colors for Business Entities, Records, and Relationships

When you model business entities in the Provisioning tool, you can configure the color and icon used to represent the business entity in Data Director. You can also configure the icon used to represent the business entity record. When you define hierarchy relationships or network relationships, you can define the color of

relationships. In Data Director, your color and icon configurations appear when you interact with records or when you view relationships in the **Hierarchy** view and **Network** view.

The following image shows the **Network** view with an icon for the SAEED Household:




Additional Pages

You can use the Provisioning tool to create additional page layouts in the Layout Designer that provide access to more information that users need. For example, you might design an additional page with primary, secondary and custom components to assist users in accessing more charts or external web applications.

When you create an additional page layout, you specify the purpose and access. For example, you might design an additional page with a task inbox and chart for a manager user role.

Hyperlinks in Business Entity Views

In Data Director, the business entity views can display some types of text as hyperlinks. To display text in the business entity fields as hyperlinks, use the Provisioning tool and configure the fields in the business entity models.

The following types of text in the business entity fields can appear as hyperlinks:

- Web URL
- File URI
- FTP link
- Email address

Installer Enhancements

The Multidomain MDM installer is updated to enhance user experience.

The installer includes the following enhancements:

- · Revised user interface text to simplify the installation process
- New and revised help text to help understand and provide the correct field values
- New window, **Configure server details for the Hub Console**, where you can specify the server details that the Hub Console requires to connect to the Hub Server machine

Hub Server Properties

You can use the following Hub Server properties to control the run-time behavior of the MDM Hub.

Configure the Hub Server properties in the *cmxserver.properties* file.

The following table describes the Hub Server properties introduced in 10.4:

Hub Server Property	Description
cmx.server.be-import.task-limit	Specifies the maximum number of records users can import for the task approval workflow to trigger. For example, if you set the property to cmx.server.be-import.task- limit=10000 a task approval workflow triggers when a user imports up to ten thousand records. If a user attempts to import more than ten thousand records, the task approval workflow does not trigger and displays an error.
cmx.server.find-replace.record-limit	Specifies the maximum number of records users can find and replace in a bulk operation. For example, if you set the property to cmx.server.find-replace.record-limit=10000 users can find and replace up to a maximum of ten thousand records.
cmx.server.find-replace.task-limit	Specifies the maximum number of replaced records that trigger the task approval workflow. For example, if you set the propertycmx.server.find-replace.task- limit=500 a task approval workflow triggers when a user replaces up to five hundred records. If a user attempts to replace more than five hundred records, an error displays.
cmx.server.find-replace.entity-record-limit	Specifies the maximum number of records users can copy from the Smart search screen to the Find and Replace screen For example, if you set the propertycmx.server.find- replace.entity-record-limit=1000 users can copy up to ten thousand records from the Smart search screen to the Find and Replace screen. If a user attempts to copy more than ten thousand records, an error displays.
cmx.file_import.job_group.ttl	Specifies the maximum time a file import job group is stored by the MDM Hub before it is deleted. You must add a suffix after the value. The following are the suffix options: day, hour, min or sec. For example, if you set the property cmx.file_import.job_group.ttl=180day the import job group is saved in MDM Hub for one hundred and eighty days.
cmx.file_import.job_group_control.ttl	Specifies the maximum time a file import job group control log is stored in the MDM Hub before it is deleted. The following are the suffix options: day, hour, min or sec. For example, if you set the property cmx.file_import.job_group_control.ttl=30day the import job group control log is saved in MDM Hub for thirty days.
cmx.file_import.mapping.temp.ttl	Specifies the maximum time to save a file import mapping in the MDM Hub temporary storage before it is deleted. The following are the suffix options: day, hour, min or sec. For example, if you set the property cmx.file_import.mapping.temp.ttl=20min the import job mapping is saved in MDM Hub for twenty minutes.

Hub Server Property	Description
cmx.file_import.mapping.system.ttl	Specifies the maximum time to save a file import mapping in the MDM Hub permanent storage before it is deleted. The following are the suffix options: day, hour, min or sec. For example, if you set the property cmx.file_import.mapping.system.ttl=20day the import job mapping is saved in MDM Hub for twenty days.
activevos.jndi	Optional. Must be added manually. Specifies the JNDI lookup string to connect report services to ActiveVOS. The default JNDI lookup string is java:/jdbc/ActiveVOS. If you edited the ActiveVOS EAR files to customize the JNDI lookup string, use this property to specify the custom JNDI lookup string.
cmx.match.training.confidence.threshold	Optional. Specifies the minimum match confidence score required to create a match rule set in the Provisioning tool.
cmx.match.training.data.encoding	Optional. Configures encoding for match training in the Provisioning tool.
cmx.server.hierarchy.max-search-depth	Maximum depth searched when you use hierarchy REST APIs to find a hierarchy path. Default value is 100.
cmx.server.hierarchy.max-search-width	Maximum width of the searched hierarchy to include when you use the hierarchy REST APIs to export. Default value is 1000000.
com.informatica.mdm.bulk.relationship.changes.limit	Maximum number of changes in a request when you use the bulk task administration REST APIs. Default value is 1000.
cmx.task.search.records.return	Controls the Elasticsearch pagination when users search for tasks in the Task Manager of Data Director with business entities. Default is 1000.
com.informatica.mdm.sifapi.xref.edit.sys0.only	Specifies whether to create edit cross-reference records through all source systems including the Admin source system.

Process Server Property

Elasticsearch Installer

Effective in version 10.4, the Multidomain MDM installer package does not include the Elasticsearch installer. You must download the supported version of the Elasticsearch installer from the Elastic website.

Previously, the Elasticsearch installer was included in the Multidomain MDM installer package.

Application Editor

Effective in version 10.4, the Applications page in the Provisioning tool is enhanced. The business entity views that you configure to display search results, appear under **Search Configuration** in the tree view. After business entity views are configured for search results, you can expand and collapse the **Search Configuration** node.

Previously, all the business entity views that you configured to display search results were listed in the properties panel and not in the tree view panel.

Upgrade Note: If you upgrade from an earlier version, the business entity views that you configured to display search results now appear under the **Search Configuration** node.

Searchable Field Options

Effective in version 10.4, the Provisioning tool no longer includes the **Searchable** field options, **Language** and **Fuzzy**, for business entity fields. To configure fuzzy search and the language of the search strings, configure Elasticsearch analyzers.

Previously, you could configure fuzzy search and the language of the search strings as **Searchable** field options.

Search Query Results Options

Effective in version 10.4, you can configure search query results to show or hide pending records.

Previously, you could not hide pending records that appeared in search query results.

Hub Console Launch

Effective in version 10.4, the Hub Console is downloaded to the client desktop as a JAR file. The Hub Console URL and your user credentials remain the same.

Previously, the Hub Console was downloaded to the client desktop as a Java Web Start application. Oracle no longer supports Java Web Start.

Communication Protocol

Effective in version 10.4, the MDM environment no longer supports EJB protocols. You must use the HTTP or HTTPS protocol for communication between the Hub Server and the Data Director screens based on the Entity 360 Framework.

To set the communication protocol, use the -De360.connection.channel Java option.

External Business Entity Services Calls and Applications

Effective in version 10.4, Multidomain MDM uses certificate-based authentication to authenticate external business entity services calls and applications. You need to configure a trusted application user for external calls and applications. Also, EJB is not supported for external calls. You must use the HTTP communication protocol instead.

Unmerge

Effective in version 10.4, you can configure Multidomain MDM to create edit cross-reference records for source systems other than the Admin source system. After this configuration, edit cross-reference records are created during PUT calls for all source systems. A cross-reference record does not unmerge if all the other cross-reference records for the base object are edit cross-reference records, which are the result of PUT calls.

Previously, edit cross-reference records were created only for the Admin source system. If PUT updates came from source systems other than the Admin source system, a cross-reference record was unmerged even though all the other cross-reference records for that base object were the result of PUT calls. This was because MDM did not identify these cross-reference records that were the result of PUT calls as edit cross-reference records.

If an obsolete property remains in the properties file after you upgrade, the property is ignored. You can safely remove the property from the file.

REST APIs

Previously, the MDM Hub used Web Application Description Language (WADL) to list all the REST URLs and parameters.

Fully Qualified Domain Name

If your environment uses the HTTPS communication protocol and the security certificate is issued to a Fully Qualified Domain Name (FQDN), configure the Java Virtual Machine (JVM) by setting the following Java option:

-De360.mdm.host

Specify the FQDN displayed in the security certificate.

Connection Protocol

For the Entity 360 application to connect to the MDM Hub Server, configure the Java Virtual Machine (JVM) by setting the following Java options:

-De360.connection.channel

Specifies the communication protocol the Entity 360 application uses to communicate with the MDM Hub Server. Specify whether the communication protocol to use is EJB, HTTP or HTTPS. Default is -De360.connection.channel=http. Ensure you set the supporting application server host property -De360.connection.channel=http. Ensure you set the supporting application server host property -De360.mdm.host and application server port property -De360.mdm.port to the default values.

You must set the following application server host and port Java options:

-De360.mdm.host

Entity 360 application server host. Specify the host used by the Java option.

-De360.mdm.port

Entity 360 application server port. To avoid conflicts, it is recommended to use the default port for the JVM.

Informatica recommends that you upgrade to JBoss EAP 7.1 and Multidomain MDM 10.3 HotFix 1 for continued support, bug fixes, and security patches from Red Hat. Multidomain MDM 10.3 HotFix 1 does not support JBoss EAP versions earlier than 7.1.

IBM WebSphere Version 9.0 Fix Pack 10 Support

You must deploy Multidomain MDM on IBM WebSphere Application Server Version 9.0 Fix Pack 10. Multidomain MDM 10.3 HotFix 1 does not support WebSphere versions earlier than 9.0 Fix Pack 10.

Red Hat OpenJDK 8 Support for JBoss

You can run Multidomain MDM 10.3 HotFix 1 on Red Hat OpenJDK 8 in a JBoss application server environment.



The performance of the Provisioning tool is enhanced by improving the response time. Changes made in the Provisioning tool are saved and published within a minute.

Message Trigger Enhancement

When a cross-reference record is restored, the MDM Hub can trigger a message to be placed in the JMS message queues. To set up message triggers for an event that restores a cross-reference record, use the Schema Manager. In the **Events** section of the **Message Triggers** page, select **Restore**, which is the new event included in the section.

Save Handler User Exit Enhancement

In Save Handler user exits, you can use the getChangedChildren method to return modified or added child or grandchild records in a specified base object.

The user exit returns all records that were added, deleted, or updated. You can select the type of changes returned by the user exit. For example, the user exit can return a combination of removed and updated children records.

Hub Server Properties

You can use the following Hub Server properties to control the run-time behavior of the MDM Hub.

Must be added manually. During an upgrade from a version before 10.3, when MDM administrators generate the business entity schema, the uppercase characters in some child-level subject area names change to lowercase. To preserve the case, set the property to 10.2.

cmx.server.put.autopopulate.missing.user.columns.bo.list

Must be added manually. Set the property when the Nullable property is disabled for the base object columns.

When the Nullable property is disabled for columns, if a record is updated in Data Director or during a SIF PUT operation, a cross-reference record is created with values only for the updated fields. All the other cross-reference record fields, including the fields that must not be null, have null values. During the best version of the truth (BVT) calculation for the record, null values can be the winner for fields that must not be null, and an error occurs.

To ensure that the BVT calculation takes into account the fields that must not be null, set the property value to a comma-separated list of the names of base objects that have columns with the Nullable property disabled. When the property is set, the MDM Hub updates the null values in the cross-reference record with values from the associated base object. This ensures that during BVT calculation, null values are not the winner for fields that must not be null.

cmx.server.enrichcopager.thread_pool

Must be added manually. Sets the number of threads the EnrichCoPager property uses from the thread pool to perform parallel ReadCO operations. Default is 30. If you set the number of threads to 1, the property is disabled.

cmx.server.enrichcopager.min_rec_for_multithreading

Must be added manually. Sets the minimum number of records to return before the EnrichCoPager property uses multithreading. Default is 2.

Java Virtual Machine Settings for Smart Search with Solr (for JBoss)

If you want to configure smart search with Solr for the MDM Hub that you deploy in a JBoss environment, configure the Java Virtual Machine (JVM) by setting the Java options for smart search.

Set the following Java options for smart search:

Dmdm.ps.zk.node

Required if you want to use smart search with Solr. Set this Java option on the JVM for the Process Server that is intended to be the ZooKeeper server. Set to true.

Dmdm.ps.search.node

Required if you want to use smart search with Solr. Set this Java option on the JVMs for the Process Servers that will have search processing enabled and function as Solr servers. Set it to true.

-Dsearch.service.port

Required if you want to use smart search with Solr. Required if you want to install multiple Process Servers on the same machine but on different JVMs and enable smart search on all the Process Servers on the machine. This Java option specifies the port used by the JVM for the search service. To avoid port conflicts, use the default port for the JVM of one Process Server, and set this Java option to the relevant port numbers for the JVMs of the remaining Process Servers.

Search with Apache Solr is Deprecated

Effective in version 10.3, the search functionality in Data Director that used Apache Solr is deprecated. Informatica will drop support for search with Solr in a future release. You can use search with Elasticsearch to find records in Data Director. Elasticsearch is an open-source, full-text search engine.

You must configure search with Elasticsearch, which is packaged with the MDM Hub installer. You can set up Elasticsearch as a single node cluster or as a multi-node cluster to provide distributed indexing and search. For a smooth transition, the APIs that were supported for search with Apache Solr are supported for search with Elasticsearch.



Related Records Component

Effective in version 10.3 HotFix 1, in the Provisioning tool, a single Related Records component replaces both the Related Records (Edit Mode) and Related Records (View Mode) components. In the new Related Records component, you can configure whether records open in view mode or edit mode. You can also configure whether the relationship direction is honored.

Previously, you had to chose which component to use. Only the Related Records (Edit Mode) component was configurable. The Related Records (View Mode) component was the default, but it was not configurable and it ignored the relationship direction.

- Perform a fuzzy search or an exact search. You can configure whether the results of a query are case sensitive or not.
- Configure a basic query or an extended query to find records that contain the query values. The basic queries use simple text comparisons to find records. Extended queries use matching logic and matchenabled attributes to find records.
- Export the current or all the columns in a query result to a CSV file.
- Customize the query results to display the columns that you want to view.
- Use the Provisioning tool to configure the views that you want to use for displaying the query results.

- Perform a fuzzy search or an exact search. The results of an exact search are not case sensitive.
- Export the current or all the columns in a search result to a CSV file.
- Customize the search results to display the columns that you want to view.
- Use the Provisioning tool to configure the views that you want to use for displaying the search results.

Localization of Data Director

In Data Director with business entities, you can display elements of the user interface in any supported language. As the MDM administrator, you can localize metadata, labels, error messages, and lookup tables. Data Director supports the following languages:

- English US
- English UK
- Portuguese
- French
- Spanish
- German
- Russian
- Japanese
- Mandarin
- Korean

Localizing Metadata

You can localize metadata elements of the Data Director user interface to display the language of your choice. Examples of metadata elements are menu names, field names, tasks and business entity names.

To localize metadata, in the Provisioning tool, download the *besMetadata.properties* zip file and edit the *bundle.properties* file for the language that you want to display. For example, for French localization, edit the *bundle_fr.properties* file. To localize task actions and task types, you must manually edit the values in the *besMetadata.properties* file by using the *taskaction.<action name>* format.

Localizing Label and Error Messages

You can localize labels and error messages of Data Director to display the language of your choice. To localize labels and error messages, you must run the *LocalizationSetup* script from the Resources Toolkit. The script is part of the MDM Hub installation package.

Localizing Lookup Tables

All lookup tables support localization. For example, the Gender, Country, and State lookup tables are mapped to the corresponding Gender, Country and State localization lookup tables.

Record View Layouts

You can design custom record view layouts to replace the **Matching Records** view, the **Hierarchy** view, and the **History** view. You can also replace the layouts for review tasks, merge tasks, and unmerge tasks.

To design a custom view, use the Provisioning tool. Create a record view layout, and specify a name, purpose, and users who can access the custom view. Then add components to the layout to build the custom view.

In Data Director, the custom views appear in the **View** list. The custom views for tasks appear in the Task Manager in Data Director.

In the custom record view for merging duplicate records and viewing record history, you can choose to display either the full business entity or a business entity view, which is a subset of fields from the business entity. Previously, these record views were default views and displayed the full business entity.

You can choose to configure the basic **Matching Records** view or the advanced **Matching Records** view for a business entity. The basic **Matching Records** view lets you merge only the duplicate parent records. The advanced **Matching Records** view lets you merge the duplicate parent and child records. You can configure one or both the **Matching Records** views for your application.

Previously, you could only design custom record view layouts to replace the default entity view.

Hiding the Default Record Views

In the Provisioning tool, you can configure a Data Director application to hide the default record views in the **View** list.

The default record views are enabled by default so that users can view and manage records in Data Director. After you design custom views, you can choose to hide the default record views to reduce confusion for your end users.

Previously, you could not hide the default record views in Data Director.

Note: When you upgrade Multidomain MDM, the View list contains the default record views by default.

Similar Records Component

You can use the Similar Records component to search for similar records when you create new records. You can decide whether you want to use search or queries to display records in the Similar Records component. You can configure exact or fuzzy queries.

Matching Records View

The Matching Records view is enhanced to make it easier for you to identify and resolving duplicate records.

The following enhancements are made to the Matching Records view:

You can now perform the following tasks:

- Resolve duplicates using the basic Matching Records view or the advanced Matching Records view. The
 basic Matching Records view lets you merge only the duplicate parent records. The advanced Matching
 Records view lets you merge the duplicate parent and child records. Your can configure Data Director to
 have one or both the Matching Records views.
- Show information that might help you in determining duplicates, such as trust scores, and display only the records that you select for merging.
- · View the match rule details for the matching records.
- Use breadcrumbs that are added to the matching records to identify the parent of the records to be merged.
- If duplicate records are missing from the **Matching Records** view, you can manually add the records to the view. To find the records that you want to add, use search or queries.
- Remove records that you do not want to merge or are not duplicates.
- Queue records for an automatic merge.
- Finalize the best version of the truth by promoting or overriding the values that you think are correct.
- Before you merge the records, you can preview the result of merging the records.

Cross-reference Records View

The **Cross-reference Records** view includes breadcrumbs to help you identify the parent records of a crossreference record. The last record listed in the breadcrumbs trail is the immediate parent of the record that is open in the **Cross-reference Records** view.

Task Manager

If you have the ActiveVOS abAdmin role assigned, you can see the workflow details of a task in the Task Manager. You can also assign a task that belong to another user of your user group back to the pool so that a different user can claim it.

Merge Tasks

The reviewer of a merge task can update the merge task during the review process.

In the review panel, reviewers can perform the following actions that are possible in the **Matching Records** view:

- Remove records that you do not want to merge.
- Finalize the best version of the truth by selecting fields with correct values or by entering the correct values.

Attach Files to Records

When you add or edit a record, you can attach files as the child records to the record. Use the Provisioning tool to configure a business entity field with FileAttachment as the data type. You can then use the business entity field to attach files in a Data Director application.

Attach Files to Tasks

You can attach files to tasks. When tasks are configured to support attachments, you can attach a file to any task that you can view. Files attached to tasks appear in the task details, and user that can view the task can view the attachment.

Comments and Attachments for Tasks

You can configure whether users must add a comment or attachment when they trigger a workflow or perform task actions. To configure the comment and attachment settings, use the Provisioning tool.

Previously, users could add comments to tasks, but you could not require users to add comments.

Workflow Triggers

You can configure a workflow trigger to prompt users for comments, attachments, or both. For example, you can configure the unmerge task trigger so that users must add a comment when they trigger unmerge tasks.

Task Types

You can configure a task type to prompt users for comments, attachments, or both. You can also allow users to attach files from the **Task Details** dialog box. For example, you can configure review tasks so that reviewers must add a comment and attachment when they reject a proposed change to a business entity record. You can configure merge tasks so that reviewers can attach files when they edit the task details.

Security for Business Entities

You can apply MDM Hub user roles to manage access to records based on business entities. You can also use data filters to manage access to records based on the values in the fields and user roles. If you want to restrict the values that can be added to a field, you can create a list of default values for the field.

User Roles and Business Entities

A business entity is a data structure with a root base object and child base objects. When you assign user role permissions to base objects and other resources in the MDM Hub Console, the record views in Data Director inherit the permissions. For example, if you grant the read permission to a user role on the base objects, the user has the same access to business entity records.

If you already have permissions assigned to user roles, you do not need to do anything else to enable the security on business entities. After you upgrade, Data Director automatically reflects the results of the user role permissions.

User Roles and REST APIs

The APIs are enhanced to support MDM Hub user roles. In all cases, a user must have permission to read a record before the other permissions are processed. The user role permissions are inherited by the business entity, and then the field filters can be used to restrict access to records based on the value in a field.

The following REST APIs return the user role privileges in the <operations> element for objects and relationships:

- GetMetadata
- ListMetadata

Data Filters with User Roles

You can create data filters on fields in a business entity and assign user roles to those filters. Based on the value in the field within a record, the user might or might not be able to see the entire record. You can also create filters on nodes to determine whether a user should have access to the parent record when the node is empty.

Note: This feature is similar to data security filters for subject areas, however data filters for business entities are case insensitive.

Tasks with User Roles

User role privileges apply to the workflow tasks that you create for business entities. A user can take an action on tasks for which they have role privileges. For example, a user can take action on a merge task only if their user role includes the merge privilege.

Default Values for Business Entities

You can add default values to fields. In Data Director, a single default value appears in the field. A list of default values appears as a drop-down list.

User Interface Enhancements for Security

When an MDM administrator creates user role privileges, the privileges affect the Data Director user interface. For example, if a user does not have access to a business entity, that user cannot see the business entity or its records.

The following table summarizes the role privileges for business entities and describes how the privileges affect the behavior of the Data Director user interface:

Business Entity Action	Data Director Behavior
Create records	In the New menu, you can see only the types of business entities for which you have permission to create records.
Read records	You can view the records for the business entities that you have permission to read. Other records are inaccessible.
Update records	In a record view, the Edit button is enabled when you have permission to edit business entity records. Otherwise, the Edit button is not visible.
Delete records	The Delete icon is enabled when you have permission to delete business entity records.

Business Entity Action	Data Director Behavior
Search for records	When searching for business entities by using search, search filters and search results contain only the business entity types that you have permission to view.
Merge and unmerge records	In the Matching Records view, the Merge button and the check boxes at the top of each record are enabled when you have permission to merge and unmerge records. If you add records to the view, the search filters and search results contain records only for the business entities that you have permission to view.

The business entity views inherit the same role privileges as the business entity. For example, if you choose to include a sensitive field in a business entity view, only the users with the role privilege for the record can view or edit it. For information about how user role privileges translate to business entities and business entity views, see the *Multidomain MDM Version 10.3 Provisioning Tool Guide*.

Hub Server Properties Introduced in Version 10.3

You can use the following Hub Server properties to control the run-time behavior of the MDM Hub.

Configure the Hub Server properties in the cmxserver.properties file.

cmx.server.selective.bvt.enabled

By default, a Put or Cleanse Put call applies BVT calculations to all fields in a record instead of updating only the fields specified in the SIF request. To specify that the MDM Hub only applies BVT calculation to fields that are part of the SIF request, set this property to true. Default is false.

cmx.file.allowed_file_extensions

Lists the extensions of files that you can attach to a record or task in the Data Director application. By default, you can attach .pdf and .jpg files. When you specify multiple extensions, separate each value by a comma.

For example, cmx.file.allowed_file_extensions=pdf,jpg,png,txt,zip,exe.

cmx.file.max_file_size_mb

Specifies the size limit of files that you can attach in the Data Director application.

Note: Data Director applications that use the subject area data model have a static size limit of 20 MB. If you specify a size limit greater than 20 MB, Data Director applications that use the subject area data model uphold the static size limit of 20 MB. Data Director applications that use the business entity data model uphold the size limit defined in the cmx.file.max_file_size_mb property.

cmx.server.attachment.temp.ttl_minutes

Number of minutes after a file is created in the TEMP storage before it expires. Set to 0 to prevent files from expiring. Default is 60.

cmx.ss.engine

Required if you want to use the Elasticsearch engine for search. Manually add the property and set to es.

ex.max.conn.per.host

Sets the maximum number of Elasticsearch nodes that you want to connect to the host. Set to the number of Elasticsearch cluster nodes on the host.

ex.max.threads

Sets the maximum number of threads that you want the Apache asynchronous non-blocking receiver to use for each node in the Elasticsearch cluster. Default is 1.

Change the value only when suggested by Informatica Global Customer Support.

es.index.refresh.interval

Sets the interval, in seconds, for Elasticsearch to commit the changes to the data after an Initially Index Smart Search Data batch job is run. The data is available for search after this time interval. Default is 30.

This property impacts the high indexing volume encountered during initial indexing. Change the value only when suggested by Informatica Global Customer Support.

ssl.keyStore

Required if you use the HTTPS port of the application server to configure the Hub Server. Manually add the property. Absolute path and file name of the keystore file.

ssl.keyStore.password

Required if you use the HTTPS port of the application server to configure the Hub Server. Manually add the property. Plain text password for the keystore file.

ssl.trustStore

Required if you use the HTTPS port of the application server to configure the Hub Server. Manually add the property. Absolute path and file name of the truststore file.

ssl.trustStore.password

Required if you use the HTTPS port of the application server to configure the Hub Server. Manually add the property. Plain text password for the truststore file.

Search with Apache Solr is Deprecated

Effective in version 10.3, the search functionality in Data Director that used Apache Solr is deprecated. Informatica will drop support for search with Solr in a future release. You can use search with Elasticsearch to find records in Data Director. Elasticsearch is an open-source, full-text search engine.

You must configure search with Elasticsearch, which is packaged with the MDM Hub installer. You can set up Elasticsearch as a single node cluster or as a multi-node cluster to provide distributed indexing and search. For a smooth transition, the APIs that were supported for search with Apache Solr are supported for search with Elasticsearch.

Task Inbox

Effective in version 10.3, you can configure the columns and the filters that you want to view in the task inbox. Use the Provisioning Tool to configure the columns and the filters for the task inbox.
